Amends the Metropolitan Water Reclamation District Act. Provides that the territory of the District is extended to include certain property in the Village of Hoffman Estates. Effective immediately.

A BILL FOR

1 AN ACT concerning local government.

2 **Be it enacted by the People of the State of Illinois,**
3 **represented in the General Assembly:**

4 Section 5. The Metropolitan Water Reclamation District Act
5 is amended by adding Section 302 as follows:

6 (70 ILCS 2605/302 new)

7 Sec. 302. District enlarged. Upon the effective date of
8 this amendatory Act of the 95th General Assembly, the corporate
9 limits of the Metropolitan Water Reclamation District are
10 extended to include within those limits the following described
11 tract of land and the tract is annexed to the District.

12 THAT PART OF THE NORTHEAST 1/4 OF SECTION 32 AND OF THE
13 NORTHWEST 1/4 OF SECTION 33, TOWNSHIP 42 NORTH, RANGE 9
14 EAST OF THE THIRD PRINCIPAL MERIDIAN, BOUNDED AND DESCRIBED
15 AS FOLLOWS:

16 COMMENCING AT THE NORTHEAST CORNER OF SECTION 32: THENCE
17 SOUTH ALONG THE WEST LINE OF SECTION 33, FOR A DISTANCE OF
18 111.37 FEET TO A POINT IN THE EASTERLY LINE OF THE ELGIN,
19 JOLIET AND EASTERN RAILWAY RIGHT OF WAY, FOR A PLACE OF
20 BEGINNING; THENCE SOUTH ALONG THE WEST LINE OF SECTION 33
21 FOR A DISTANCE OF 1,208.29 FEET TO THE NORTH LINE OF THE

1 SOUTH 1/2 OF THE NORTHWEST 1/4 OF SECTION 33, THENCE EAST
2 ALONG THE NORTH LINE OF THE SOUTH 1/2 OF THE NORTHWEST 1/4
3 OF SECTION 33 FOR A DISTANCE OF 1,291.45 FEET TO THE CENTER
4 LINE OF SUTTON ROAD; THENCE SOUTH ALONG THE CENTER LINE OF
5 PUBLIC HIGHWAY KNOWN AS SUTTON ROAD, TO THE INTERSECTION OF
6 SAID CENTER LINE OF SUTTON ROAD WITH THE NORTH LINE OF THE
7 RIGHT OF WAY OF THE ILLINOIS STATE ROUTE 72, AS NOW
8 LOCATED; THENCE NORTHWESTERLY ALONG THE NORTH LINE OF STATE
9 ROUTE 72 TO ITS INTERSECTION WITH THE EAST LINE OF RIGHT OF
10 WAY OF THE ELGIN, JOLIET AND EASTERN RAILWAY AND THENCE
11 NORTHERLY ALONG SAID EAST LINE OF THE RAILWAY RIGHT OF WAY,
12 TO THE PLACE OF BEGINNING, IN COOK COUNTY, ILLINOIS.

13 Section 99. Effective date. This Act takes effect upon
14 becoming law.
