2	AMENDMENT NO Amend House Bill 5768 by replacing
3	everything after the enacting clause with the following:
4	"Section 5. The State of Illinois owns the following
5	described real estate:
6	THE SOUTH 20 ACRES OF THE FOLLOWING DESCRIBED TRACT:
7	THE WEST 1,024.24 FEET OF THE EAST HALF OF THE SOUTHWEST
8	QUARTER OF SECTION 24, TOWNSHIP 14 NORTH, RANGE 12 WEST OF THE
9	2ND PRINCIPAL MERIDIAN EXCEPT THE WEST 33' OF EVEN WIDTH
10	THEREOF.
11	ALSO BEING MORE PARTICULARLY DESCRIBED AS BEGINNING AT THE
12	SOUTHWEST CORNER OF THE EAST HALF OF THE SOUTHWEST QUARTER OF
13	SECTION 24, TOWNSHIP 14 NORTH, RANGE 12 WEST OF THE 2ND
14	PRINCIPAL MERIDIAN; THENCE NORTH 90 DEGREES 00 MINUTES 00

1 SECONDS EAST (ASSUMED BEARING), ALONG THE SOUTH LINE OF SAID 2 EAST HALF, 33 FEET TO THE TRUE POINT OF BEGINNING; THENCE NORTH 3 00 DEGREES 10 MINUTES 52 SECONDS EAST, 878.90 FEET; THENCE 4 NORTH 90 DEGREES 00 MINUTES 00 SECONDS EAST, 991.24 FEET; 5 THENCE SOUTH 00 DEGREES 10 MINUTES 52 SECONDS WEST, 878.90 FEET 6 TO THE SOUTH LINE OF SAID EAST HALF; THENCE SOUTH 90 DEGREES 00 MINUTES 00 SECONDS WEST ALONG SAID SOUTH LINE 991.24 FEET TO 7 THE TRUE POINT OF BEGINNING. BEING ALL SITUATED IN PARIS 8 9 TOWNSHIP, EDGAR COUNTY, ILLINOIS AND CONTAINING 20.00 ACRES.

10 THE ABOVE DESCRIBED PROPERTY IS SUBJECT TO A DEDICATED RIGHT OF 11 WAY FOR PUBLIC ROAD AND PUBLIC UTILITY PURPOSES OVER THE SOUTH 12 45 FEET OF EVEN WIDTH THEREOF. AS RECORDED IN BOOK 12 OF 13 EASEMENTS, PAGE 92 AND DATED SEPTEMBER 6, 1990 OF THE RECORDS 14 OF EDGAR COUNTY, ILLINOIS.

15 Section 10. Upon the payment of the sum of \$1 to the State of Illinois, and subject to the conditions set forth in Section 16 17 10 of this Act, the Director of Corrections, on behalf of the 18 State of Illinois and all State Agencies, must convey by 19 quitclaim deed all right, title, and interest of the State of 20 Illinois in and to the Ed Jenison Work Camp located in Edgar 21 County, Illinois to the City of Paris as described in Section 22 5.

Section 15. The quit claim deed shall state on its face and

be subject to the condition that if the property is no longer used for public purposes, then title shall revert without further action to the State of Illinois.

4 Section 20. The Director of Corrections shall obtain a 5 certified copy of this Act within 60 days after its effective 6 date, and shall record the certified document in the recorder's 7 office in the county in which the land is located.

8 Section 99. Effective date. This Act takes effect upon 9 becoming law.".
