1 Section 10. The amount of \$500,000, or so much of that 2 amount as may be necessary, is appropriated to the State 3 Treasurer from the Matured Bond and Coupon Fund for payment 4 of matured bonds and interest coupons pursuant to Section 6u 5 of the State Finance Act.

6 Section 15. The amount of \$225,450, or so much thereof as 7 may be necessary is appropriated from the Capital Litigation 8 Trust Fund to the State Treasurer for the State Treasurer's 9 costs to administer the Capital Litigation Trust Fund in 10 accordance with the Capital Crimes Litigation Act.

11 Section 20. The following named amount of \$275,000, or so 12 much thereof as may be necessary, is appropriated from the 13 General Revenue Fund to the State Treasurer for expenses 14 related to an Inspector General position.

ARTICLE 999

Section 999. Effective Date. This Act takes effect July 17 1, 2008.".
