# Be it enacted by the People of the State of Illinois, represented in the General Assembly:

4 Section 5. 4 Section 10. The amount of \$325,000, or so much of that 5 amount as may be necessary, is appropriated from the Court of 6 Claims Administration and Grant Fund to the Court of Claims 7 for administrative expenses under the Crime Victims 8 Compensation Act.

9 Section 15. The amount of \$500,000, or so much of that 10 amount as may be necessary, is appropriated from the General 11 Revenue Fund to the Court of Claims for payment of awards 12 solely as a result of the lapsing of an appropriation 13 originally made from any funds held by the State Treasurer.

Section 20. The sum of \$13,000,000 or so much thereof as may be necessary, is appropriated from the General Revenue Fund to the Court of Claims for payment of line of duty awards.

18 Section 25. The following named amounts, or so much of 19 that amount as may be necessary, are appropriated to the 20 Court of Claims for payment of claims as follows:
