Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- 1 Section 15. The sum of \$713,200, or so much thereof as
- 2 may be necessary, is appropriated from the General Revenue
- 3 Fund to the Illinois Arts Council for the purpose of funding
- 4 administrative and grant expenses associated with humanities
- 5 programs and related activities.
- 6 Section 20. The amount of \$271,100, or so much thereof
- 7 as may be necessary, is appropriated from the General Revenue
- 8 Fund to the Illinois Arts Council for grants to certain
- 9 public radio and television stations for operating costs.
- Section 25. The amount of \$3,494,800, or so much thereof
- 11 as may be necessary is appropriated from the General Revenue
- 12 Fund to the Illinois Arts Council for grants to certain
- 13 public radio and television stations and related
- 14 administrative expenses, pursuant to the Public Radio and
- 15 Television Grant Act.
- 16 Section 99. Effective Date. This Act takes effect July
- 17 1, 2008.
