AMENDMENT NO. . Amend House Bill 6364, by deleting 2

everything after the enacting clause and inserting in lieu

4 thereof the following:

5 "ARTICLE 1

Section 5. The following named amounts, or so much 6 thereof as may be necessary, respectively, for the objects and purposes hereinafter named, are appropriated to the 8 9 Office of the State Treasurer to meet its ordinary and contingent expenses for the fiscal year ending June 30, 2009:

Section 10. The amount of \$8,100,000, or so much thereof 12

as may be necessary, is appropriated to the State Treasurer

from the Banking Services Trust Fund for the purpose of

- 1 making payments to financial institutions for banking
- 2 services pursuant to the State Treasurer's Bank Services
- 3 Trust Fund Act.
- 4 Section 15. The amount of \$9,000,000 or so much thereof
- 5 as may be necessary, is appropriated to the State Treasurer
- 6 from the General Revenue Fund for the purpose of making
- 7 refunds of overpayments of estate tax and accrued interest on
- 8 those overpayments, if any, and payment of certain statutory
- 9 costs of assessment.
- Section 20. The amount of \$6,000,000, or so much thereof
- 11 as may be necessary, is appropriated to the State Treasurer
- 12 from the General Revenue Fund for the purpose of making
- 13 refunds of accrued interest on protested tax cases.
- 14 Section 25. The amount of \$27,000,000, or so much
- 15 thereof as may be necessary, is appropriated to the State
- 16 Treasurer from the Transfer Tax Collection Distributive Fund
- for the purpose of making payments to counties pursuant to
- 18 Section 13b of the Illinois Estate and Generation-Skipping
- 19 Transfer Tax.
- 20 Section 30. The amount of \$2,941,200, or so much thereof
- 21 as may be necessary, is appropriated from the Capital

- 1 Litigation Trust Fund to the State Treasurer for a block
- 2 grant to the Cook County Treasurer for the separate account
- 3 for payment of expenses of the Cook County State's Attorney
- 4 in capital cases in Cook County in accordance with the
- 5 Capital Crimes Litigation Act.
- 6 Section 35. The amount of \$1,750,000, or so much thereof
- 7 as may be necessary, is appropriated from the Capital
- 8 Litigation Trust Fund to the State Treasurer for a block
- 9 grant to the Cook County Treasurer for the separate account
- 10 for payment of expenses of the Cook County Public Defender in
- 11 capital cases in Cook County in accordance with the Capital
- 12 Crimes Litigation Act.
- 13 Section 40. The amount of \$2,000,000, or so much thereof
- 14 as may be necessary, is appropriated from the Capital
- 15 Litigation Trust Fund to the State Treasurer for a block
- 16 grant to the Cook County Treasurer for the separate account
- for payment of compensation and expenses of court appointed
- 18 defense counsel, other than the Cook County Public Defender,
- 19 in capital cases in Cook County in accordance with the
- 20 Capital Crimes Litigation Act.
- 21 Section 45. The amount of \$3,000,000, or so much thereof
- 22 as may be necessary, is appropriated from the Capital

- 1 Litigation Trust Fund to the State Treasurer for the separate
- 2 account held by the State Treasurer for the separate account
- 3 held by the State Treasurer for payment of compensation and
- 4 expenses of the court appointed counsel other than Public
- 5 Defenders incurred in the defense of capital cases in
- 6 counties other than Cook County in accordance with the
- 7 Capital Crimes Litigation Act.
- 8 Section 50. The amount of \$500,000, or so much thereof
- 9 as may be necessary, is appropriated from the Capital
- 10 Litigation Trust Fund to the State Treasurer for the separate
- 11 account held by the State Treasurer for payment of expenses
- of Public Defenders incurred in the defense of capital cases
- in counties other than Cook County in accordance with the
- 14 Capital Crimes Litigation Act.

ARTICLE 999

- 16 Section 999. Effective Date. This Act takes effect
- 17 July 1, 2008.".
