1 AMENDMENT TO HOUSE BILL 6374

2 AMENDMENT NO. _____. Amend House Bill 6374, by deleting
3 everything after the enacting clause and inserting in lieu
4 thereof the following:

5 "ARTICLE 1

6 Section 5. The amount of \$500,000, or so much of that
7 amount as may be necessary, is appropriated from the General
8 Revenue Fund to the Court of Claims for payment of awards
9 solely as a result of the lapsing of an appropriation
10 originally made from any funds held by the State Treasurer.

11 Section 10. The sum of \$13,000,000 or so much thereof as
12 may be necessary, is appropriated from the General Revenue
13 Fund to the Court of Claims for payment of line of duty

1 awards.

2 Section 15. The following named amounts, or so much of
3 that amount as may be necessary, are appropriated to the
4 Court of Claims for payment of claims as follows:
