1 AMENDMENT TO HOUSE BILL 6608

2 AMENDMENT NO. _____. Amend House Bill 6608, by deleting
3 everything after the enacting clause and inserting in lieu
4 thereof the following:

5 "ARTICLE 1

6 Section 5. The sum of \$37,000,000, or so much thereof as
7 may be necessary, is appropriated from the Criminal Justice
8 Trust Fund to the Illinois Criminal Justice Information
9 Authority for awards and grants to local units of government
10 and non-profit organizations.

11 Section 10. The sum of \$12,000,000, or so much thereof
12 as may be necessary, is appropriated from the Criminal

1 Justice Trust Fund to the Illinois Criminal Justice
 2 Information Authority for awards and grants to state
 3 agencies.

4 Section 15. The following named sums, or so much thereof
 5 as may be necessary, are appropriated to the Illinois
 6 Criminal Justice Information Authority for activities
 7 undertaken in support of federal assistance programs
 8 administered by units of state and local government and non-
 9 profit organizations:

13 Section 20. The following named amounts, or so much
 14 thereof as may be necessary, are appropriated to the Illinois
 15 Criminal Justice Information Authority for awards and grants
 16 and other monies received from federal agencies, from other
 17 units of government, and from private/not-for-profit
 18 organizations for activities undertaken in support of
 19 investigating issues in criminal justice and for undertaking
 20 other criminal justice information projects:

22	Trust Fund	1,700,000
23	Payable from the Criminal Justice	

1 Information Projects Fund400,000
 2 Total \$2,100,000

3 Section 25. The following named amounts, or so much
 4 thereof as may be necessary, respectively, for the objects
 5 and purposes hereinafter named, are appropriated to the
 6 Illinois Criminal Justice Information Authority for awards,
 7 grants and operational support to implement the Motor Vehicle
 8 Theft Prevention Act:

9 Motor Vehicle Theft Prevention Act6,500,000
 10 Total \$6,500,000

11 Section 30. The sum of \$10,000,000, or so much thereof
 12 as may be necessary, is appropriated from the Criminal
 13 Justice Trust Fund to the Illinois Criminal Justice
 14 Information Authority for awards and grants to state agencies
 15 and units of local government, to include operational
 16 activities and programs undertaken by the Authority, in
 17 support of Federal Crime Bill Initiatives.

18 Section 35. The sum of \$4,500,000, or so much thereof as
 19 may be necessary, is appropriated from the Juvenile
 20 Accountability Incentive Block Grant Trust Fund to the
 21 Illinois Criminal Justice Information Authority for awards
 22 and grants to state agencies and units of local government,

1 including operational expenses of the Authority in support of
2 the Juvenile Accountability Incentive Block Grant program.

3 ARTICLE 999

4 Section 999. Effective Date. This Act takes effect July
5 1, 2008."
