

95TH GENERAL ASSEMBLY State of Illinois 2007 and 2008 SB0036

Introduced 1/31/2007, by Sen. Christine Radogno - Kirk W. Dillard

SYNOPSIS AS INTRODUCED:

5 ILCS 420/4A-102 from Ch. 127, par. 604A-102 5 ILCS 420/4A-103 from Ch. 127, par. 604A-103 5 ILCS 420/4A-104 from Ch. 127, par. 604A-104 10 ILCS 5/9-28

Amends the Illinois Governmental Ethics Act and the Election Code. With respect to the disclosure of gifts in statements of economic interests, requires that (i) gifts to the spouse of the person making the statement and to immediate family members living in the same household are considered gifts to the person making the statement; (ii) gifts from persons and entities (now, entities) be disclosed; and (iii) the nature and value of each gift be specified. Requires that the State Board of Elections' website include with filed campaign finance reports (i) a notice that statements of economic interests contain information about public officials and candidates and (ii) a link to the Secretary of State website pages containing statements of economic interests of State officials and candidates. Effective July 1, 2007.

1 AN ACT concerning ethics.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Illinois Governmental Ethics Act is amended by changing Sections 4A-102, 4A-103, and 4A-104 as follows:
- 6 (5 ILCS 420/4A-102) (from Ch. 127, par. 604A-102)
- 7 Sec. 4A-102. The statement of economic interests required by this Article shall include the economic interests of the 8 9 person making the statement as provided in this Section. The interest (if constructively controlled by the person making the 10 statement) of a spouse or any other party, shall be considered 11 to be the same as the interest of the person making the 12 statement. A gift to a spouse or to an immediate family member 13 14 living in the same household as the person making the statement (from a person or entity other than the person making the 15 16 statement, the spouse, or an immediate family member living in 17 the same household) shall be considered a gift to the person making the statement. Campaign receipts shall not be included 18 19 in this statement.
 - (a) The following interests shall be listed by all persons required to file:
- 22 (1) The name, address and type of practice of any 23 professional organization or individual professional

practice in which the person making the statement was an officer, director, associate, partner or proprietor, or served in any advisory capacity, from which income in excess of \$1200 was derived during the preceding calendar year;

- (2) The nature of professional services (other than services rendered to the unit or units of government in relation to which the person is required to file) and the nature of the entity to which they were rendered if fees exceeding \$5,000 were received during the preceding calendar year from the entity for professional services rendered by the person making the statement.
- (3) The identity (including the address or legal description of real estate) of any capital asset from which a capital gain of \$5,000 or more was realized in the preceding calendar year.
- (4) The name of any unit of government which has employed the person making the statement during the preceding calendar year other than the unit or units of government in relation to which the person is required to file.
- (5) The name of any <u>person from whom or</u> entity from which a gift or gifts, or honorarium or honoraria, valued singly or in the aggregate in excess of \$500, was received during the preceding calendar year <u>and the nature and value</u> of each gift or honorarium received from the named person

<u>or entity</u>.

- (b) The following interests shall also be listed by persons listed in items (a) through (f) and item (l) of Section 4A-101:
 - (1) The name and instrument of ownership in any entity doing business in the State of Illinois, in which an ownership interest held by the person at the date of filing is in excess of \$5,000 fair market value or from which dividends of in excess of \$1,200 were derived during the preceding calendar year. (In the case of real estate, location thereof shall be listed by street address, or if none, then by legal description). No time or demand deposit in a financial institution, nor any debt instrument need be listed:
 - (2) Except for professional service entities, the name of any entity and any position held therein from which income of in excess of \$1,200 was derived during the preceding calendar year, if the entity does business in the State of Illinois. No time or demand deposit in a financial institution, nor any debt instrument need be listed.
 - (3) The identity of any compensated lobbyist with whom the person making the statement maintains a close economic association, including the name of the lobbyist and specifying the legislative matter or matters which are the object of the lobbying activity, and describing the general type of economic activity of the client or principal on whose behalf that person is lobbying.

- (c) The following interests shall also be listed by persons listed in items (g), (h), and (i) of Section 4A-101:
 - (1) The name and instrument of ownership in any entity doing business with a unit of local government in relation to which the person is required to file if the ownership interest of the person filing is greater than \$5,000 fair market value as of the date of filing or if dividends in excess of \$1,200 were received from the entity during the preceding calendar year. (In the case of real estate, location thereof shall be listed by street address, or if none, then by legal description). No time or demand deposit in a financial institution, nor any debt instrument need be listed.
 - (2) Except for professional service entities, the name of any entity and any position held therein from which income in excess of \$1,200 was derived during the preceding calendar year if the entity does business with a unit of local government in relation to which the person is required to file. No time or demand deposit in a financial institution, nor any debt instrument need be listed.
 - (3) The name of any entity and the nature of the governmental action requested by any entity which has applied to a unit of local government in relation to which the person must file for any license, franchise or permit for annexation, zoning or rezoning of real estate during the preceding calendar year if the ownership interest of

- 9 Section 9-28 as follows:
- 10 (10 ILCS 5/9-28)
- 11 Sec. 9-28. Electronic filing and availability. The Board
- 12 shall by rule provide for the electronic filing of expenditure
- and contribution reports as follows:
- Beginning July 1, 1999, or as soon thereafter as the Board
- 15 has provided adequate software to the political committee,
- 16 electronic filing is required for all political committees that
- during the reporting period (i) had at any time a balance or an
- accumulation of contributions of \$25,000 or more, (ii) made
- 19 aggregate expenditures of \$25,000 or more, or (iii) received
- loans of an aggregate of \$25,000 or more.
- Beginning July 1, 2003, electronic filing is required for
- 22 all political committees that during the reporting period (i)
- 23 had at any time a balance or an accumulation of contributions
- of \$10,000 or more, (ii) made aggregate expenditures of \$10,000

or more, or (iii) received loans of an aggregate of \$10,000 or more.

The Board may provide by rule for the optional electronic filing of expenditure and contribution reports for all other political committees. The Board shall promptly make all reports filed under this Article by all political committees publicly available by means of a searchable database that is accessible through the World Wide Web. The searchable database required by this subsection must include a notice that statements of economic interests required by the Illinois Governmental Ethics Act and filed with the Secretary of State contain information about State officials and candidates and that statements of economic interests required by the Illinois Governmental Ethics Act and filed with county clerks contain information about local officials and candidates. The database also must include a link to the Secretary of State website pages that contain statements of economic interests filed with the Secretary of State.

The Board shall provide all software necessary to comply with this Section to candidates, public officials, political committees, and election authorities.

The Board shall implement a plan to provide computer access and assistance to candidates, public officials, political committees, and election authorities with respect to electronic filings required under this Article.

For the purposes of this Section, "political committees"
