SYNOPSIS AS INTRODUCED:

20 ILCS 1305/10-26 305 ILCS 5/5-5e new

Amends the Department of Human Services Act and the Illinois Public Aid Code. Provides that, for purposes of the Department of Human Services' disability database, "developmental disabilities" include autism spectrum disorders. In connection with Medicaid, provides that a person diagnosed with an autism spectrum disorder shall be considered a person with a "developmental disability" or a "person with a related condition" for purposes of determining eligibility for services under Home and Community-Based Services Waivers for persons with developmental disabilities, without regard to whether that person is also diagnosed with mental retardation and without regard to that person's IQ level, so long as the person otherwise meets applicable level-of-care criteria under those waivers. Effective immediately.

1 AN ACT concerning public aid.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

- Section 5. The Department of Human Services Act is amended
 by changing Section 10-26 as follows:
- 6 (20 ILCS 1305/10-26)

7 Sec. 10-26. Disability database.

(a) The Department of Human Services shall compile and 8 9 maintain a cross-disability database of Illinois residents with a disability who are potentially in need of disability 10 services funded by the Department. The database shall consist 11 of individuals with mental illness, physical disabilities, and 12 including <u>autism</u> spectrum 13 developmental disabilities, 14 disorders, and shall include, but not be limited to, individuals transitioning from special education to adulthood, 15 16 individuals in State-operated facilities, individuals in 17 private nursing and residential facilities, and individuals in community integrated living arrangements. Within 30 days after 18 19 the effective date of this amendatory Act of the 93rd General 20 Assembly, the Secretary of Human Services shall seek input from 21 advisory bodies to the Department, including advisory councils 22 and committees working with the Department in the areas of illness, physical disabilities, and developmental 23 mental

1 disabilities. The database shall be operational by July 1, 2 2004. The information collected and maintained for the disability database shall include, but is not limited to, the 3 following: (i) the types of services of which the individual is 4 5 potentially in need; (ii) demographic and identifying 6 information about the individual; (iii) factors indicating 7 need, including diagnoses, assessment information, age of 8 primary caregivers, and current living situation; (iv) if 9 applicable, the date information about the individual is submitted for inclusion in the database and the types of 10 11 services sought by the individual; and (v) the representative 12 district in which the individual resides. In collecting and 13 maintaining information under this Section, the Department shall give consideration to cost-effective appropriate 14 15 services for individuals.

16 (b) This amendatory Act of the 93rd General Assembly does 17 not create any new entitlement to a service, program, or benefit, but shall not affect any entitlement to a service, 18 19 program, or benefit created by any other law. Except for a 20 service, program, or benefit that is an entitlement, a service, program, or benefit provided as a result of the collection and 21 22 maintenance of the disability database shall be subject to 23 appropriations made by the General Assembly.

(c) The Department, consistent with applicable federal and
State law, shall make general information from the disability
database available to the public such as: (i) the number of

individuals potentially in need of each type of service, 1 2 program, or benefit and (ii) the general characteristics of 3 those individuals. The Department shall protect the when 4 confidentiality of each individual in the database 5 releasing database information by not disclosing any personally identifying information. 6

8 Section 10. The Illinois Public Aid Code is amended by 9 adding Section 5-5e as follows:

11 Sec. 5-5e. Home and Community Based Services Waivers; autism as "developmental disability". A person diagnosed with 12 an autism spectrum disorder shall be considered a person with a 13 14 "developmental disability" or a "person with a related 15 condition" for purposes of determining eligibility for 16 services under Home and Community-Based Services Waivers for 17 persons with developmental disabilities, without regard to whether that person is also diagnosed with mental retardation 18 and without regard to that person's IQ level, so long as the 19 20 person otherwise meets applicable level-of-care criteria under 21 those waivers. This amendatory Act of the 95th General Assembly 22 does not create any new entitlement to a service, program, or 23 benefit, but shall not affect any entitlement to a service, 24 program, or benefit created by any other law.
