2 AMENDMENT NO. \_\_\_\_\_. Amend Senate Bill 689, immediately  
3 below the enacting clause, by inserting the following:

4 "Section 3. The State Finance Act is amended by renumbering  
5 and changing Section 5.595, as added by Public Act 92-870, and  
6 by changing Section 6z-60 as follows:

12 Sec. 1. Short title. This Act may be cited as the  
13 Mid-Illinois ~~Illinois~~ Medical District ~~at Springfield~~ Act.

16 Sec. 5. Creation of District. There is created in the City  
17 of Springfield a medical center district, the Mid-Illinois  
18 ~~Illinois~~ Medical District ~~at Springfield~~, whose boundaries are  
19 11th Street on the east, North Grand Avenue on the north,  
20 Walnut Street on the west, and Madison Street on the south, all  
21 in the City of Springfield, Illinois. The District is created  
22 to attract and retain academic centers of excellence, viable

1 health care facilities, medical research facilities, emerging  
2 high technology enterprises, and other facilities and uses as  
3 permitted by this Act.

6 Sec. 7. District Training Program Area. The training  
7 program area of the Mid-Illinois Medical District may be  
8 limited to the following counties in Illinois: Cass, Christian,  
9 Logan, Macoupin, Mason, Menard, Montgomery, Morgan, Sangamon,  
10 and Scott.

12 Sec. 10. Mid-Illinois ~~Illinois~~ Medical District ~~at~~  
13 ~~Springfield~~ Commission.

14 (a) There is created a body politic and corporate under the  
15 corporate name of the Mid-Illinois ~~Illinois~~ Medical District ~~at~~  
16 ~~Springfield~~ Commission whose general purpose, in addition to  
17 and not in limitation of those purposes and powers set forth in  
18 this Act, is to:

19 (1) maintain the proper surroundings for a medical  
20 center and a related technology center in order to attract,  
21 stabilize, and retain within the District hospitals,  
22 clinics, research facilities, educational facilities, or  
23 other facilities permitted under this Act; ~~and~~

24 (2) provide for the orderly creation, maintenance,

1 development, and expansion of (i) health care facilities  
2 and other ancillary or related facilities that the  
3 Commission may from time to time determine are established  
4 and operated (A) for any aspect of the carrying out of the  
5 Commission's purposes as set forth in this Act, (B) for the  
6 study, diagnosis, and treatment of human ailments and  
7 injuries, whether physical or mental, or (C) to promote  
8 medical, surgical, and scientific research and knowledge  
9 as permitted under this Act; and (ii) medical research and  
10 high technology parks, together with the necessary lands,  
11 buildings, facilities, equipment, and personal property  
12 for those parks; and.

13 (3) convene dialogue among leaders in the public and  
14 the private sectors on topics and issues associated with  
15 training in the delivery of health care services in the  
16 District's program area.

17 (b) The Commission has perpetual succession and the power  
18 to contract and be contracted with, to sue and be sued except  
19 in actions sounding in tort, to plead and be impleaded, to have  
20 and use a common seal, and to alter the same at pleasure. All  
21 actions sounding in tort against the Commission shall be  
22 prosecuted in the Court of Claims. The principal office of the  
23 Commission shall be in the City of Springfield.

24 (c) The Commission shall consist of the following members:  
25 4 members appointed by the Governor, with the advice and  
26 consent of the Senate; 4 members appointed by the Mayor of

1 Springfield, with the advice and consent of the Springfield  
2 city council; and one member appointed by the Chairperson of  
3 the County Board of Sangamon County. The initial members of the  
4 Commission appointed by the Governor shall be appointed for  
5 terms ending, respectively on the second, third, fourth, and  
6 fifth anniversaries of their appointments. The initial members  
7 appointed by the Mayor of Springfield shall be appointed 2 each  
8 for terms ending, respectively, on the second and third  
9 anniversaries of their appointments. The initial member  
10 appointed by the Chairperson of the County Board of Sangamon  
11 County shall be appointed for a term ending on the fourth  
12 anniversary of the appointment. Thereafter, all the members  
13 shall be appointed to hold office for a term of 5 years and  
14 until their successors are appointed as provided in this Act.

15 Within 60 days after the effective date of this amendatory  
16 Act of the 95th General Assembly, the Governor shall appoint 2  
17 additional members to the Commission. One member shall serve  
18 for a term of 4 years and one member shall serve for a term of 5  
19 years. Their successors shall be appointed for 5-year terms.  
20 Those additional members and their successors shall be limited  
21 to residents of the following counties in Illinois: Cass,  
22 Christian, Logan, Macoupin, Mason, Menard, Montgomery, Morgan,  
23 or Scott.

24 (d) Any vacancy in the membership of the Commission  
25 occurring by reason of the death, resignation,  
26 disqualification, removal, or inability or refusal to act of

1 any of the members of the Commission shall be filled by the  
2 authority that had appointed the particular member, and for the  
3 unexpired term of office of that particular member. A vacancy  
4 caused by the expiration of the period for which the member was  
5 appointed shall be filled by a new appointment for a term of 5  
6 years from the date of the expiration of the prior 5-year term  
7 notwithstanding when the appointment is actually made. The  
8 Commission shall obtain, under the provisions of the Personnel  
9 Code, such personnel as to the Commission shall deem advisable  
10 to carry out the purposes of this Act and the work of the  
11 Commission.

12 (e) The Commission shall hold regular meetings annually for  
13 the election of a President, Vice-President, Secretary, and  
14 Treasurer, for the adoption of a budget, and for such other  
15 business as may properly come before it. The Commission shall  
16 elect as the President a member of the Commission appointed by  
17 the Mayor of Springfield and as the Vice-President a member of  
18 the Commission appointed by the Governor. The Commission shall  
19 establish the duties and responsibilities of its officers by  
20 rule. The President or any 4 ~~3~~ members of the Commission may  
21 call special meetings of the Commission. Each Commissioner  
22 shall take an oath of office for the faithful performance of  
23 his or her duties. The Commission may not transact business at  
24 a meeting of the Commission unless there is present at the  
25 meeting a quorum consisting of at least 6 ~~5~~ Commissioners.  
26 Meetings may be held by telephone conference or other

1 communications equipment by means of which all persons  
2 participating in the meeting can communicate with each other.

3 (f) The Commission shall submit to the General Assembly,  
4 not later than March 1 of each odd-numbered year, a detailed  
5 report covering its operations for the 2 preceding calendar  
6 years and a statement of its program for the next 2 years.

7 The requirement for reporting to the General Assembly shall  
8 be satisfied by filing copies of the report with the Speaker,  
9 the Minority Leader, and the Clerk of the House of  
10 Representatives and the President, the Minority Leader, and the  
11 Secretary of the Senate and with the Legislative Research Unit,  
12 as required by Section 3.1 of the General Assembly Organization  
13 Act, and by filing such additional copies with the State  
14 Government Report Distribution Center for the General Assembly  
15 as is required under paragraph (t) of Section 7 of the State  
16 Library Act.

17 (g) The Auditor General shall conduct audits of the  
18 Commission in the same manner as the Auditor General conducts  
19 audits of State agencies under the Illinois State Auditing Act.

20 (h) Neither the Commission nor the District have any power  
21 to tax.

22 (i) The Commission is a public body and subject to the Open  
23 Meetings Act and the Freedom of Information Act.
