2 AMENDMENT NO. _____. Amend Senate Bill 1132 by replacing 3 everything after the enacting clause with the following:

"ARTICLE 1

Section 1. The following appropriations in this Article 5 1 are in addition to all other amounts previously appropriated 6 7 to the Court of Claims for fiscal year 2007 for the stated purposes from the stated funds. The following 8 and 9 appropriations are for fiscal year 2007.

10 Section 5. The sum of \$7,723,532.86, or so much thereof as 11 may be necessary, is appropriated from the General Revenue 12 Fund to the Court of Claims for payment of line of duty 13 awards. 09500SB1132sam002
