Amends the Counties Code. Repeals Sections creating and establishing the Board of the Department of Corrections. Provides that the Sheriff shall appoint the Director of the Department of Corrections with the advice and consent of the county board (instead of from a list of nominations by the Board of the Department of Corrections).

Sec. 3-15012. Director. The Sheriff shall appoint a Director to act as the chief executive and administrative officer of the Department. The Director shall be appointed by the Sheriff with the advice and consent of the county board from a list of 3 persons nominated by the members of the Board.

- 1 He or she shall serve at the pleasure of the Sheriff. If the
- 2 Director is removed, the Sheriff shall appoint his or her
- 3 replacement with the advice and consent of the county board the
- 4 Board shall nominate 3 persons, one of whom shall be selected
- 5 by the Sheriff to serve as Director. The Director's
- 6 compensation is determined by the County Board.
