being taken against the applicant or licensee and that the 1 license may be suspended, revoked, placed on probationary 2 3 status, or other disciplinary action may be taken, including limiting the scope, nature, or extent of practice, as the 4 5 Secretary Director may deem proper. Written notice may be served by personal delivery to the applicant or licensee or by 6 7 mailing the notice by certified mail to his or her last known 8 place of residence or to the place of business last specified 9 by the applicant or licensee in his or her last notification to 10 the Department. If the person fails to file an answer after 11 receiving notice, his or her license may, in the discretion of 12 Department, be suspended, revoked, or the placed on probationary status or the Department may take whatever 13 disciplinary action deemed proper, including limiting the 14 scope, nature, or extent of the person's practice or the 15 imposition of a fine, without a hearing, if the act or acts 16 17 charged constitute sufficient grounds for such action under this Act. At the time and place fixed in the notice, the 18 19 Department shall proceed to hearing of the charges and both the 20 applicant or licensee and the complainant shall be afforded ample opportunity to present, in person or by counsel, any 21 22 statements, testimony, evidence, and arguments that may be 23 pertinent to the charges or to their defense. The Department 24 may continue a hearing from time to time. If the Board is not 25 sitting at the time and place fixed in the notice or at the 26 time and place to which the hearing shall have been continued,
