A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named amounts, or so much  
6 thereof as may be necessary, respectively, are appropriated  
7 to the Illinois Student Assistance Commission from the  
8 Student Loan Operating Fund for its ordinary and contingent  
9 expenses:

5 Section 6. The sum of \$34,400,000, or so much thereof as  
6 may be necessary, is appropriated from the Student Loan  
7 Operating Fund to the Illinois Student Assistance Commission  
8 for payment of the Monetary Award Program Plus grant awards  
9 to students eligible to receive such awards, as provided by  
10 law.

11 Section 7. The sum of \$26,840,000, or so much thereof as  
12 may be necessary, is appropriated from the Student Loan  
13 Operating Fund to the Illinois Student Assistance Commission  
14 for payment of the Monetary Award Program grant awards to  
15 students eligible to receive such awards, as provided by law.

16 Section 10. The sum of \$361,559,800, or so much thereof  
17 as may be necessary, is appropriated to the Illinois Student  
18 Assistance Commission from the General Revenue Fund for  
19 payment of Monetary Award Program grant awards to students  
20 eligible to receive such awards, as provided by law.

21 Section 15. The following named amounts, or so much

1     thereof as may be necessary, respectively, are appropriated  
 2     from the General Revenue Fund to the Illinois Student  
 3     Assistance Commission for the following purposes:

4                     Grants and Scholarships

5     For payment of matching grants to Illinois  
 6     institutions to supplement scholarship  
 7     programs, as provided by law .....950,000

8     For the payment of scholarships to students  
 9     who are children of policemen or firemen  
 10    killed in the line of duty, or who are  
 11    dependents of correctional officers killed  
 12    or permanently disabled in the line of  
 13    duty, as provided by law .....520,000

14    For payment of Illinois National Guard and  
 15    Naval Militia Scholarships at  
 16    State-controlled universities and public  
 17    community colleges in Illinois to students  
 18    eligible to receive such awards, as  
 19    provided by law .....4,480,000

20    For payment of military Veterans' scholarships  
 21    at State-controlled universities and at  
 22    public community colleges for students  
 23    eligible, as provided by law .....19,250,000

24    For payment of Minority Teacher Scholarships .....3,100,000

25    For payment of Illinois Scholars Scholarships .....3,020,000

1 For payment of Illinois Incentive for Access  
 2 grants, as provided by law .....8,400,000  
 3 For college savings bond grants to  
 4 students who are eligible to  
 5 receive such awards .....650,000  
 6 Total \$40,370,000

7 Section 20. The following named amount, or so much  
 8 thereof as may be necessary, is appropriated from the  
 9 Illinois National Guard and Naval Militia Grant Fund to the  
 10 Illinois Student Assistance Commission for the following  
 11 purpose:

12 Grants and Scholarships

13 For payment of Illinois National Guard and  
 14 Naval Militia Scholarships  
 15 at State-controlled universities  
 16 and public community colleges in  
 17 Illinois to students eligible to  
 18 receive such awards, as provided by law .....20,000

19 Section 25. The sum of \$500,000, or so much thereof as  
 20 may be necessary, is appropriated from the General Revenue  
 21 Fund to the Illinois Student Assistance Commission for the  
 22 Loan Repayment for Teachers Program.

1           Section 30. The sum of \$500,000, or so much thereof as  
2 may be necessary, is appropriated from the General Revenue  
3 Fund to the Illinois Student Assistance Commission for  
4 scholarships and living expenses grants to increase the  
5 number of forensic science students who are pursuing a  
6 program to become qualified to perform DNA testing at  
7 Illinois State Police forensic science facilities.

8           Section 35. The sum of \$1,350,000, or so much thereof as  
9 may be necessary, is appropriated from the General Revenue  
10 Fund to the Illinois Student Assistance Commission for  
11 scholarships and living expenses grants for nursing education  
12 students who are pursuing their Master's degree to become  
13 nurse faculty.

14           Section 37. The sum of \$3,250,000, or so much thereof as  
15 may be necessary, is appropriated from the General Revenue  
16 Fund to the Illinois Student Assistance Commission for grants  
17 to eligible nurse educators to use for payment of their  
18 educational loan.

19           Section 40. The following named amount, or so much  
20 thereof as may be necessary, is appropriated from the General  
21 Revenue Fund to the Illinois Student Assistance Commission

1 for the following purpose:

2 Grants and Scholarships

3 For payment of Illinois Future Teacher

4 Corps Scholarships, as provided by law .....4,100,000

5 Section 45. The following named amount, or so much  
6 thereof as may be necessary, is appropriated from the  
7 Contracts and Grants Fund to the Illinois Student Assistance  
8 Commission for the following purpose:

9 To support outreach, research, and

10 training activities .....455,000

11 Section 50. The following named amount, or so much  
12 thereof as may be necessary, is appropriated from the  
13 Optometric Licensing and Disciplinary Board Fund to the  
14 Illinois Student Assistance Commission for the following  
15 purpose:

16 Grants and Scholarships

17 For payment of scholarships for the

18 Optometric Education Scholarship

19 Program, as provided by law .....50,000

20 Section 55. The sum of \$260,000,000, or so much thereof  
21 as may be necessary, is appropriated from the Federal Student  
22 Loan Fund to the Illinois Student Assistance Commission for

1 distribution when necessary as a result of the following: for  
2 guarantees of loans that are uncollectible, for collection  
3 payments to the Student Loan Operating Fund as required under  
4 agreements with the United States Secretary of Education, for  
5 payment to the Student Loan Operating Fund for Default  
6 Aversion Fees, for transfers to the U.S. Treasury, or for  
7 other distributions as necessary and provided for under the  
8 Federal Higher Education Act.

9 Section 60. The sum of \$10,000,000, or so much thereof  
10 as may be necessary, is appropriated to the Illinois Student  
11 Assistance Commission from the Student Loan Operating Fund  
12 for distribution as necessary for the following: for payment  
13 of collection agency fees associated with collection  
14 activities for Federal Family Education Loans, for Default  
15 Aversion Fee reversals, for payment of Claim Fees, and other  
16 necessary transfers from the Student Loan Operating Fund to  
17 the Federal Student Loan Fund, and other distributions as  
18 necessary and provided for under the Federal Higher Education  
19 Act, as amended.

20 Section 65. The sum of \$4,000,000, or so much thereof as  
21 may be necessary, is appropriated to the Illinois Student  
22 Assistance Commission from the Student Loan Operating Fund  
23 for costs associated with Federal Loan System Development and



1 Maintenance.

2 Section 66. The following named amount, or so much  
3 thereof as may be necessary, is appropriated from the Student  
4 Loan Operating Fund to the Illinois Student Assistance  
5 Commission for the following purposes:

6 For payments to the Federal Student  
7 Loan Fund for payment of the federal  
8 default fee on behalf of students,  
9 or for any other lawful purpose  
10 authorized by the Federal Higher  
11 Education Act, as amended.....16,000,000

12 Section 70. The sum of \$300,000, or so much of that  
13 amount as may be necessary, is appropriated from the Accounts  
14 Receivable Fund to the Illinois Student Assistance Commission  
15 for costs associated with the collection of delinquent  
16 scholarship awards pursuant to the Illinois State Collection  
17 Act of 1986.

18 Section 75. The following named amount, or so much  
19 thereof as may be necessary, is appropriated from the Federal  
20 Student Assistance Scholarship Fund to the Illinois Student  
21 Assistance Commission for the following purpose:

1 For payment of Robert C. Byrd  
 2 Honors Scholarships .....1,800,000

3 Section 80. The sum of \$70,000, or so much thereof as  
 4 may be necessary, is appropriated to the Illinois Student  
 5 Assistance Commission from the University Grant Fund for  
 6 payment of grants for the Higher Education License Plate  
 7 Program, as provided by law.

8 Section 85. The following named amount, or so much  
 9 thereof as may be necessary, is appropriated from the Federal  
 10 Student Assistance Scholarship Fund to the Illinois Student  
 11 Assistance Commission for the following purpose:

12 For transferring repayment funds collected  
 13 under the Paul Douglas Teacher Scholarship  
 14 Program to the U.S. Treasury .....400,000

15 Section 90. The following named amount, or so much  
 16 thereof as may be necessary, is appropriated from the  
 17 Illinois Future Teacher Corps Scholarship Fund to the  
 18 Illinois Student Assistance Commission for the following  
 19 purpose:

20 For payment of scholarships for the  
 21 Illinois Future Teacher Corps  
 22 Scholarship Program as provided by law .....57,000

1 For payment for grants to the Golden Apple  
 2 Foundation for Excellence in Teaching .....3,000

3 Section 95. The following named amount, or so much  
 4 thereof as may be necessary, is appropriated from the Federal  
 5 Student Incentive Trust Fund for the Federal Leveraging  
 6 Educational Assistance and the Supplemental Leveraging  
 7 Educational Assistance Programs to the Illinois Student  
 8 Assistance Commission for the following purpose:

9 Grants

10 For payment of Monetary Award Program grants to  
 11 full-time and part-time students eligible  
 12 to receive such grants, as provided by law .....3,700,000

13 Section 100. The sum of \$2,276,900, or so much thereof  
 14 as may be necessary, is appropriated from the Student Loan  
 15 Operating Fund to the Illinois Student Assistance Commission  
 16 for costs and expenses related to or in support of a higher  
 17 education shared services center.

18 Section 999. Effective date. This Act takes effect July  
 19 1, 2007.
