1 AN ACT concerning civil law.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Eminent Domain Act is amended by adding Section 25-5-15 as follows:

- Sec. 25-5-15. Quick-take; County of DuPage. Quick-take

 proceedings under Article 20 may be used for a period of 12

 months after the effective date of this amendatory Act of the

 95th General Assembly by the County of DuPage for the purpose

 of implementation of Phase II of the Huffman Street Flood

 Control Project for stormwater management and flood control as

 follows:
- That part of the northeast quarter of Section 18, Township 14 15 38 north, Range 10 east of the third principal meridian, 16 described by commencing at the northeast corner of said 17 Section 18 running thence south along the section line, 18 3.95 chains (260.70') to the centerline of the public 19 highway known as the Old Plank Road; Thence south 44 1/2 20 degrees west along said centerline, 12.49 chains (824.34') 21 to the east line of a tract of land formerly owned by 22 Schifferle for a place of beginning; Thence north 44
