Makes appropriations and reappropriations to the University of Illinois for various purposes, including for ordinary and contingent expenses. Effective July 1, 2008.

A BILL FOR

1 AN ACT making appropriations and reappropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 Section 5. The following named amounts, or so much
5 thereof as may be necessary, respectively, for the objects
6 and purposes hereinafter named, are appropriated to the Board
7 of the Trustees of the University of Illinois to meet
8 ordinary and contingent expenses for the fiscal year ending
9 June 30, 2009:

10 Payable from the General Revenue Fund:

11	For Personal Services, including payment	
12	to the university for personal services	
13	costs incurred during the fiscal year	
14	and salaries accrued but unpaid to academic	
15	personnel for personal services rendered	
16	during the 2007-2008 academic year	\$617,042,400
17	For State Contributions to Social	
18	Security, for Medicare	9,737,100
19	For Group Insurance	24,893,200
20	For Contractual Services	44,193,200
21	For Travel	249,700
22	For Commodities	2,518,600
23	For Equipment	511,000

1	For Telecommunications Services	5,016,800

12 Section 10. The sum of \$2,445,500, or so much thereof as
13 may be necessary, is appropriated from the Fire Prevention
14 Fund to the Board of Trustees of the University of Illinois
15 for the purpose of maintaining the Illinois Fire Service
16 Institute, paying the Institute's expenses, and providing the
17 facilities and structures incident thereto, including payment
18 to the University for personal services and related costs
19 incurred.

20 Section 15. The sum of \$250,000, or so much thereof as
21 may be necessary, is appropriated from the State College and
22 University Trust Fund to the Board of Trustees of the
23 University of Illinois for scholarship grant awards, in

1 accordance with Public Act 91-83.

2 Section 20. The sum of \$1,000,000, or so much thereof as
3 may be necessary, is appropriated from the General Revenue
4 Fund to the University of Illinois for the Complete Help and
5 Assistance Necessary for a College Education (C.H.A.N.C.E)
6 program at the Office of School Relations at the Chicago
7 campus.

8 Section 25. The sum of \$400,000, or so much thereof as
9 may be necessary, is appropriated from the General Revenue
10 Fund to the Board of Trustees of the University of Illinois
11 for costs associated with the Hispanic Center for Excellence
12 at the Chicago campus.

13 Section 30. The sum of \$350,000, or so much thereof as
14 may be necessary, is appropriated from the General Revenue
15 Fund to the Board of Trustees of the University of Illinois
16 for Dixon Springs Agricultural Center.

17 Section 33. The sum of \$1,000,000, or so much thereof as
18 may be necessary, is appropriated from the General Revenue
19 Fund to the Board of Trustees of the University of Illinois
20 for the ordinary and contingent expenses of technology
21 transfer.

1 Section 35. The sum of \$4,484,764, or so much thereof as
2 may be necessary and remains unexpended at the close of
3 business on June 30, 2008, from a reappropriation heretofore
4 made for that purpose in Article 530, Section 5 of Public Act
5 95-348, is reappropriated from the Capital Development Fund
6 to the Board of Trustees of the University of Illinois for
7 all costs associated with the space needs of the Department
8 of Natural Resources, Illinois Natural History Survey
9 Division and State Water Survey Division, on the campus of
10 the University of Illinois in Champaign, including
11 construction, capital facilities, planning, relocation,
12 renovation and rehabilitation, mechanical systems, materials,
13 services, and all other costs required to complete the work.

14 Section 40. The sum of \$260,566, or so much thereof as
15 may be necessary and remains unexpended on June 30, 2008,
16 from a reappropriation heretofore made for such purpose in
17 Article 530, Section 10 of Public Act 95-348, is
18 reappropriated from the Capital Development Fund to the
19 University of Illinois for digitalization infrastructure for
20 WILL-TV (Urbana-Champaign).

21 Section 45. The sum of \$21,097, or so much thereof as may
22 be necessary and remains unexpended on June 30, 2008, from a

1 reappropriation heretofore made for such purpose in Article
2 530, Section 15 of Public Act 95-348, is reappropriated from
3 the Capital Development Fund to the University of Illinois at
4 Springfield for constructing a classroom and office building,
5 in addition to funds previously appropriated.

6 Section 99. Effective date. This Act takes effect July 1,
7 2008.
