A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named amounts, or so much
6 thereof as may be necessary, respectively, are appropriated
7 to the Illinois Student Assistance Commission from the
8 Student Loan Operating Fund for its ordinary and contingent
9 expenses:

4 Section 10. The sum of \$381,099,800, or so much thereof
5 as may be necessary, is appropriated to the Illinois Student
6 Assistance Commission from the Education Assistance Fund for
7 payment of Monetary Award Program grant awards to students
8 eligible to receive such awards, as provided by law.

9
10 Section 11. The sum of \$19,250,000, or so much thereof
11 as may be necessary, is appropriated to the Illinois Student
12 Assistance Commission from the Education Assistance Fund for
13 payment of military veterans' scholarships at state-
14 controlled universities and at public community colleges for
15 students eligible, as provided by law.

16 Section 15. The following named amounts, or so much
17 thereof as may be necessary, respectively, are appropriated
18 from the General Revenue Fund to the Illinois Student
19 Assistance Commission for the following purposes:

20 Grants and Scholarships
21 For payment of matching grants to Illinois
22 institutions to supplement scholarship
23 programs, as provided by law950,000

1	For the payment of scholarships to students	
2	who are children of policemen or firemen	
3	killed in the line of duty, or who are	
4	dependents of correctional officers killed	
5	or permanently disabled in the line of	
6	duty, as provided by law	470,000
7	For payment of Illinois National Guard and	
8	Naval Militia Scholarships at

21 Section 20. The following named amount, or so much
 22 thereof as may be necessary, is appropriated from the
 23 Illinois National Guard and Naval Militia Grant Fund to the
 24 Illinois Student Assistance Commission for the following

1 purpose:

2 Grants and Scholarships

3 For payment of Illinois National Guard and
 4 Naval Militia Scholarships
 5 at State-controlled universities
 6 and public community colleges in
 7 Illinois to students eligible to
 8 receive such awards, as provided by law20,000

9 Section 25. The sum of \$500,000, or so much thereof as
 10 may be necessary, is appropriated from the General Revenue
 11 Fund to the Illinois Student Assistance Commission for the
 12 Loan Repayment for Teachers Program.

13 Section 35. The sum of \$1,350,000, or so much thereof as
 14 may be necessary, is appropriated from the General Revenue
 15 Fund to the Illinois Student Assistance Commission for
 16 scholarships and living expenses grants for nursing education
 17 students who are pursuing their Master's degree to become
 18 nurse faculty.

19 Section 40. The sum of \$1,220,000, or so much thereof as
 20 may be necessary, is appropriated from the General Revenue
 21 Fund to the Illinois Student Assistance Commission for costs
 22 associated with the Veterans' Home Nurses' Loan Repayment

1 Program pursuant to Public Act 95-0576.

2 Section 45. The sum of \$1,000,000 or so much thereof as
3 may be necessary, is appropriated from the General Revenue
4 Fund to the Illinois Student Assistance Commission for grants
5 to eligible nurse educators to use for payment of their
6 educational loan pursuant to Public Act 94-1020.

7 Section 50. The following named amount, or so much
8 thereof as may be necessary, is appropriated from the General
9 Revenue Fund to the Illinois Student Assistance Commission
10 for the following purpose:

11	Grants and Scholarships	
12	For payment of Illinois Future Teacher	
13	Corps Scholarships, as provided by law	4,100,000

14 Section 55. The following named amount, or so much
15 thereof as may be necessary, is appropriated from the
16 Contracts and Grants Fund to the Illinois Student Assistance
17 Commission for the following purpose:

18	To support outreach, research, and	
19	training activities	1,500,000

20 Section 60. The following named amount, or so much
21 thereof as may be necessary, is appropriated from the

1 Optometric Licensing and Disciplinary Board Fund to the
2 Illinois Student Assistance Commission for the following
3 purpose:

4 Grants and Scholarships

5 For payment of scholarships for the
6 Optometric Education Scholarship
7 Program, as provided by law50,000

8 Section 65. The sum of \$260,000,000, or so much thereof
9 as may be necessary, is appropriated from the Federal Student
10 Loan Fund to the Illinois Student Assistance Commission for
11 distribution when necessary as a result of the following: for
12 guarantees of loans that are uncollectible, for collection
13 payments to the Student Loan Operating Fund as required under
14 agreements with the United States Secretary of Education, for
15 payment to the Student Loan Operating Fund for Default
16 Aversion Fees, for transfers to the U.S. Treasury, or for
17 other distributions as necessary and provided for under the
18 Federal Higher Education Act.

19 Section 70. The sum of \$21,334,400, or so much thereof
20 as may be necessary, is appropriated to the Illinois Student
21 Assistance Commission from the Student Loan Operating Fund
22 for distribution as necessary for the following: for payment
23 of collection agency fees associated with collection

1 activities for Federal Family Education Loans, for Default
 2 Aversion Fee reversals, and for distributions as necessary
 3 and provided for under the Federal Higher Education Act.

4 Section 75. The sum of \$3,500,000, or so much thereof as
 5 may be necessary, is appropriated to the Illinois Student
 6 Assistance Commission from the Student Loan Operating Fund
 7 for costs associated with Federal Loan System Development and
 8 Maintenance.

9 Section 80. The following named amount, or so much
 10 thereof as may be necessary, is appropriated from the Student
 11 Loan Operating Fund to the Illinois Student Assistance
 12 Commission for the following purposes:

13 For payments to the Federal Student
 14 Loan Fund for payment of the federal
 15 default fee on behalf of students,
 16 or for any other lawful purpose
 17 authorized by the Federal Higher
 18 Education Act, as amended10,000,000

19 Section 85. The sum of \$300,000, or so much of that
 20 amount as may be necessary, is appropriated from the Accounts
 21 Receivable Fund to the Illinois Student Assistance Commission
 22 for costs associated with the collection of delinquent

1 scholarship awards pursuant to the Illinois State Collection
2 Act of 1986.

3 Section 90. The following named amount, or so much
4 thereof as may be necessary, is appropriated from the Federal
5 Student Assistance Scholarship Fund to the Illinois Student
6 Assistance Commission for the following purpose:

7 For payment of Robert C. Byrd
8 Honors Scholarships3,000,000

9 Section 95. The sum of \$70,000, or so much thereof as
10 may be necessary, is appropriated to the Illinois Student
11 Assistance Commission from the University Grant Fund for
12 payment of grants for the Higher Education License Plate
13 Program, as provided by law.

14 Section 100. The following named amount, or so much
15 thereof as may be necessary, is appropriated from the Federal
16 Student Assistance Scholarship Fund to the Illinois Student
17 Assistance Commission for the following purpose:

18 For transferring repayment funds collected
19 under the Paul Douglas Teacher Scholarship
20 Program to the U.S. Treasury400,000

21 Section 105. The following named amount, or so much

1 thereof as may be necessary, is appropriated from the
 2 Illinois Future Teacher Corps Scholarship Fund to the
 3 Illinois Student Assistance Commission for the following
 4 purpose:

5 For payment of scholarships for the
 6 Illinois Future Teacher Corps
 7 Scholarship Program as provided by law57,000
 8 For payment for grants to the Golden Apple
 9 Foundation for Excellence in Teaching3,000

10 Section 110. The following named amount, or so much
 11 thereof as may be necessary, is appropriated from the Federal
 12 Student Incentive Trust Fund for the Federal Leveraging
 13 Educational Assistance and the Supplemental Leveraging
 14 Educational Assistance Programs to the Illinois Student
 15 Assistance Commission for the following purpose:

16 Grants
 17 For payment of Monetary Award Program grants to
 18 full-time and part-time students eligible
 19 to receive such grants, as provided by law4,200,000

20 Section 115. The sum of \$5,000,000, or so much thereof
 21 may be necessary, is appropriated from the Federal Student
 22 Incentive Trust Fund to the Illinois Student Assistance
 23 Commission for payment of grants for the Federal College

1 Access Challenge Grant Program, with up to six percent of the
2 funding appropriated to meet allowable administrative costs,
3 as part of the College Cost Reduction and Access Act (CCRAA),
4 as provided by law.

5 Section 120. The sum of \$2,128,100, or so much thereof
6 as may be necessary, is appropriated from the Student Loan
7 Operating Fund to the Illinois Student Assistance Commission
8 for costs and expenses related to or in support of a higher
9 education shared services center.

10 Section 999. Effective Date. This Act takes effect July
11 1, 2008.
