- 2 prominently displays the level of caffeine contained in the
- drink measured in milligrams per ounce and a warning indicating
- 4 that ingesting high levels of caffeine may pose a health risk
- 5 to children. For the purpose of this Section, "energy drink"
- 6 means any softdrink with a caffeine level of 5.9 mg or more per
- 7 ounce.

- 9 Sec. 4. In addition to the remedies hereinafter provided
- 10 the Director is authorized to file a complaint and apply to the
- 11 circuit court for, and such court may upon hearing and for
- cause shown grant, a temporary restraining order or preliminary
- or permanent injunction restraining any person from violating
- any provision of Sections 3.1 through 3.23 3.21.
