SYNOPSIS AS INTRODUCED:

35 ILCS 5/218 new

Amends the Illinois Income Tax Act. Allows an income tax credit for each individual taxpayer who is a teacher, instructor, counselor, principal, or aide who worked in a school in Illinois for at least 900 hours during the taxable year. Provides that the amount of the credit is equal to 25% of the eligible classroom expenses made by the taxpayer during the taxable year, but the credit may not exceed \$250. Defines "eligible classroom expenses" as the aggregate amount of nonreimbursed classroom expenses made by the taxpayer during the taxable year less \$250. Provides that the credit may not be carried forward or back and may not reduce the taxpayer's liability to less than zero. Effective immediately.

- (a) For taxable years ending on or after December 31, 2009, 8 9 each individual taxpayer who is a qualified education 10 professional is entitled to a credit against the tax imposed by subsections (a) and (b) of Section 201 in an amount equal to 11 12 25% of the eligible classroom expenses made by the taxpayer during the taxable year, but the credit may not exceed \$250. 13 14 (b) For the purpose of this Section: "Eligib<u>le classroom expenses" means the aggregate amount</u> 15 16 of nonreimbursed classroom expenses made by the taxpayer during 17 the taxable year less \$250. 18 "Qualified education professional" means a teacher, instructor, counselor, principal, or aide who worked in a 19 school in Illinois for at least 900 hours during the taxable 20 21 year.
