4 Section 5. The Illinois Vehicle Code is amended by changing 5 Sections 12-821 and 20-204 and by adding Section 3-684 as 6 follows:

- 8 Sec. 3-684. Distinguished Flying Cross license plates.
- 9 (a) In addition to any other special license plate, the Secretary, upon receipt of all applicable fees and applications 10 made in the form prescribed by the Secretary of State, may 11 12 issue Distinguished Flying Cross license plates to residents of Illinois who have been awarded the Distinguished Flying Cross 13 14 medal by the United States Armed Forces. The special Distinguished Flying Cross plates issued under this Section 15 shall be affixed only to passenger vehicles of the first 16 17 division, motorcycles, and motor vehicles of the second division weighing not more than 8,000 pounds. Plates issued 18 19 under this Section shall expire according to the staggered multi-year procedure established by Section 3-414.1 of this 20 21 Code.
- 22 (b) The design, color, and format of the plates shall be 23 wholly within the discretion of the Secretary of State. The

Secretary may, in his or her discretion, allow the plates to be issued as vanity plates or personalized in accordance with Section 3-405.1 of this Code. The plates are not required to designate "Land Of Lincoln", as prescribed in subsection (b) of Section 3-412 of this Code. The Secretary shall, in his or her discretion, approve and prescribe stickers or decals as provided under Section 3-412.

8 <u>(c) An applicant shall be charged a \$15 fee for original</u> 9 <u>issuance in addition to the applicable registration fee. This</u> 10 <u>additional fee shall be deposited into the Secretary of State</u> 11 <u>Special License Plate Fund.</u>

13 Sec. 12-821. Display of telephone number; complaint calls.

(a) Each school bus shall display at the rear of the bus a
sign, with letters and numerals readily visible and readable,
indicating the <u>area code and</u> telephone number of the owner of
the school bus, regardless of whether the owner is a school
district or another person or entity. The sign shall <u>be in the</u>
following form:

7 (b) The owner of each school bus shall establish procedures
8 for accepting the calls provided for under subsection (a) and
9 for taking complaints.

10 (c) The procedures established under subsection (b) shall 11 include, but not be limited to:

12 (1) an internal investigation of the events that led to13 each complaint; and

14 (2) a report to the complaining party on the results of15 the investigation and the action taken, if any.
