2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

4 Section 5. The Fish and Aquatic Life Code is amended by 5 changing Section 20-45 as follows:

6 (515 ILCS 5/20-45) (from Ch. 56, par. 20-45)

Sec. 20-45. License fees for residents. Fees for licenses
for residents of the State of Illinois shall be as follows:

9 (a) Except as otherwise provided in this Section, for sport fishing devices as defined in Section 10-95 or 10 spearing devices as defined in Section 10-110 the fee is 11 \$12.50 for individuals 16 to 64 years old, and one-half of 12 13 the current fishing license fee for individuals age 65 or 14 older, and, commencing with the 2010 license year, one-half of the current fishing license fee for resident veterans of 15 16 the United States Armed Forces after returning from service 17 abroad or mobilization by the President of the United States , commencing with the 1994 license year. Veterans 18 19 must provide, to the Department at the Department's office 20 in Springfield, verification of their service. The 21 Department shall establish what constitutes suitable 22 verification of service for the purpose of issuing fishing licenses to resident veterans at a reduced fee. 23

1 (b) All residents before using any commercial fishing device shall obtain a commercial fishing license, the fee 2 3 for which shall be \$35. Each and every commercial device used shall be licensed by a resident commercial fisherman 5 as follows:

> (1) For each 100 lineal yards, or fraction thereof, of seine the fee is \$18. For each minnow seine, minnow trap, or net for commercial purposes the fee is \$20.

9 (2) For each device to fish with a 100 hook trot 10 line device, basket trap, hoop net, or dip net the fee 11 is \$3.

12 (3) When used in the waters of Lake Michigan, for the first 2000 lineal feet, or fraction thereof, of 13 14 gill net the fee is \$10; and for each 1000 additional 15 lineal feet, or fraction thereof, the fee is \$10. These 16 fees shall apply to all gill nets in use in the water or on drying reels on the shore. 17

(4) For each 100 lineal yards, or fraction thereof, 18 19 of gill net or trammel net the fee is \$18.

20 (c) Residents of the State of Illinois may obtain a sportsmen's combination license that shall entitle the 21 22 holder to the same non-commercial fishing privileges as 23 residents holding a license as described in subsection (a) 24 of this Section and to the same hunting privileges as 25 residents holding a license to hunt all species as 26 described in Section 3.1 of the Wildlife Code. sportsmen's combination license shall be issued to any 1 individual who would be ineligible for either the fishing 2 3 or hunting license separately. The sportsmen's combination license fee shall be \$18.50. For residents age 65 or older, 4 5 the fee is one-half of the fee charged for a sportsmen's 6 combination license. For resident veterans of the United 7 States Armed Forces after returning from service abroad or 8 mobilization by the President of the United States, the 9 fee, commencing with the 2010 license year, is one-half of 10 the fee charged for a sportsmen's combination license. 11 Veterans must provide, to the Department at the 12 Department's office in Springfield, verification of their 13 service. The Department shall establish what constitutes 14 suitable verification of service for the purpose of issuing 15 sportsmen's combination licenses to resident veterans at a 16 reduced fee.

17 (d) For 24 hours of fishing by sport fishing devices as defined in Section 10-95 or by spearing devices as defined 18 in Section 10-110 the fee is \$5. This license exempts the 19 20 licensee from the requirement for a salmon or inland trout 21 stamp. The licenses provided for by this subsection are not 22 required for residents of the State of Illinois who have 23 obtained the license provided for in subsection (a) of this 24 Section.

(e) All residents before using any commercial mussel
 device shall obtain a commercial mussel license, the fee

1 for which shall be \$50.

2 Residents of this State, upon establishing (f) 3 residency as required by the Department, may obtain a lifetime hunting or fishing license lifetime 4 or 5 sportsmen's combination license which shall entitle the holder to the same non-commercial fishing privileges as 6 7 residents holding a license as described in paragraph (a) 8 of this Section and to the same hunting privileges as 9 residents holding a license to hunt all species as 10 described in Section 3.1 of the Wildlife Code. No lifetime 11 sportsmen's combination license shall be issued to or 12 retained by any individual who would be ineligible for 13 either the fishing or hunting license separately, either upon issuance, or in any year a violation would subject an 14 15 individual to have either or both fishing or hunting 16 privileges rescinded. The lifetime hunting and fishing 17 license fees shall be as follows:

18 (1) Lifetime fishing: 30 x the current fishing19 license fee.

20 (2) Lifetime hunting: 30 x the current hunting21 license fee.

(3) Lifetime sportsmen's combination license: 30 x
the current sportsmen's combination license fee.
Lifetime licenses shall not be refundable. A \$10 fee shall
be charged for reissuing any lifetime license. The Department
may establish rules and regulations for the issuance and use of

lifetime licenses and may suspend or revoke any lifetime 1 2 license issued under this Section for violations of those rules or regulations or other provisions under this Code or the 3 Wildlife Code. Individuals under 16 years of age who possess a 4 5 lifetime hunting or sportsmen's combination license shall have in their possession, while in the field, a certificate of 6 7 competency as required under Section 3.2 of the Wildlife Code. 8 Any lifetime license issued under this Section shall not exempt 9 individuals from obtaining additional stamps or permits 10 required under the provisions of this Code or the Wildlife 11 Code. Individuals required to purchase additional stamps shall 12 sign the stamps and have them in their possession while fishing 13 or hunting with a lifetime license. All fees received from the issuance of lifetime licenses shall be deposited in the Fish 14 15 and Wildlife Endowment Fund.

Except for licenses issued under subsection (e) of this Section, all licenses provided for in this Section shall expire on March 31 of each year, except that the license provided for in subsection (d) of this Section shall expire 24 hours after the effective date and time listed on the face of the license.

All individuals required to have and failing to have the license provided for in subsection (a) or (d) of this Section shall be fined according to the provisions of Section 20-35 of this Code.

Section 10. The Wildlife Code is amended by changing
Section 3.2 as follows:

7 Sec. 3.2. Hunting license; application; instruction. 8 Before the Department or any county, city, village, township, 9 incorporated town clerk or his duly designated agent or any 10 other person authorized or designated by the Department to 11 issue hunting licenses shall issue a hunting license to any 12 person, the person shall file his application with the 13 Department or other party authorized to issue licenses on a 14 form provided by the Department and further give definite proof 15 identity and place of legal residence. Each clerk of designating agents to issue licenses and stamps shall furnish 16 17 the Department, within 10 days following the appointment, the 18 names and mailing addresses of the agents. Each clerk or his duly designated agent shall be authorized to sell licenses and 19 20 stamps only within the territorial area for which he was 21 elected or appointed. No duly designated agent is authorized to furnish licenses or stamps for issuance by any other business 22 23 establishment. 1 and place of residence.

2 No hunting license shall be issued to any person born on or 3 after January 1, 1980 unless he presents the person authorized to issue the license evidence that he has held a hunting 4 5 license issued by the State of Illinois or another state in a prior year, or a certificate of competency as provided in this 6 7 Section. Persons under 16 years of age may be issued a Lifetime 8 Hunting or Sportsmen's Combination License as provided under 9 Section 20-45 of the Fish and Aquatic Life Code but shall not 10 be entitled to hunt unless they have a certificate of 11 competency as provided in this Section and they shall have the 12 certificate in their possession while hunting.

Department of Natural Resources shall authorize 13 The personnel of the Department or certified volunteer instructors 14 15 to conduct courses, of not less than 10 hours in length, in 16 firearms and hunter safety, which may include training in bow 17 and arrow safety, at regularly specified intervals throughout the State. Persons successfully completing the course shall 18 19 receive a certificate of competency. The Department of Natural 20 Resources may further cooperate with any reputable association 21 or organization in establishing courses if the organization has 22 as one of its objectives the promotion of safety in the 23 handling of firearms or bow and arrow.

persons so appointed shall give the course of instruction and 1 2 upon the successful completion shall issue to the person instructed a certificate of competency in the safe handling of 3 firearms, hunter safety, and bow and arrow. No charge shall be 4 5 made for any course of instruction except for materials or 6 ammunition consumed. The Department of Natural Resources shall 7 furnish information on the requirements of hunter safety 8 education programs to be distributed free of charge to 9 applicants for hunting licenses by the persons appointed and 10 authorized to issue licenses. Funds for the conducting of 11 firearms and hunter safety courses shall be taken from the fee 12 charged for the Firearm Owners Identification Card.

13 The fee for a hunting license to hunt all species for a 14 resident of Illinois is \$7. For residents age 65 or older and, commencing with the 2010 license year, for resident veterans of 15 16 the United States Armed Forces after returning from service 17 abroad or mobilization by the President of the United States, the fee is one-half of the fee charged for a hunting license to 18 hunt all species for a resident of Illinois. Veterans must 19 20 provide, to the Department at the Department's office in Springfield, verification of their service. The Department 21 22 shall establish what constitutes suitable verification of 23 service for the purpose of issuing resident veterans hunting licenses at a reduced fee. Nonresidents shall be charged \$50 24 25 for a hunting license.

Nonresidents may be issued a nonresident hunting license

for a period not to exceed 10 consecutive days' hunting in the
 State and shall be charged a fee of \$28.

A special nonresident hunting license authorizing 3 а nonresident to take game birds by hunting on a game breeding 4 5 and hunting preserve area only, established under Section 3.27, 6 shall be issued upon proper application being made and payment 7 of a fee equal to that for a resident hunting license. The 8 expiration date of this license shall be on the same date each 9 year that game breeding and hunting preserve area licenses 10 expire.

Each applicant for a State Migratory Waterfowl Stamp, regardless of his residence or other condition, shall pay a fee of \$10 and shall receive a stamp. Except as provided under Section 20-45 of the Fish and Aquatic Life Code, the stamp shall be signed by the person or affixed to his license or permit in a space designated by the Department for that purpose.

Each applicant for a State Habitat Stamp, regardless of his residence or other condition, shall pay a fee of \$5 and shall receive a stamp. Except as provided under Section 20-45 of the Fish and Aquatic Life Code, the stamp shall be signed by the person or affixed to his license or permit in a space designated by the Department for that purpose.

Nothing in this Section shall be construed as to require the purchase of more than one State Habitat Stamp by any person in any one license year. HB0998 Engrossed - 10 - LRB096 03070 JDS 13085 b

1 The Department shall furnish the holders of hunting 2 licenses and stamps with an insignia as evidence of possession 3 of license, or license and stamp, as the Department may 4 consider advisable. The insignia shall be exhibited and used as 5 the Department may order.

6 All other hunting licenses and all State stamps shall 7 expire upon March 31 of each year.

8 Every person holding any license, permit, or stamp issued 9 under the provisions of this Act shall have it in his 10 possession for immediate presentation for inspection to the 11 officers and authorized employees of the Department, any 12 sheriff, deputy sheriff, or any other peace officer making a 13 demand for it. This provision shall not apply to Department owned or managed sites where it is required that all hunters 14 license, permit, 15 deposit their or Firearm Owner's 16 Identification Card at the check station upon entering the 17 hunting areas.
