AN ACT concerning professional regulation.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

4 Section 5. The Respiratory Care Practice Act is amended by 5 changing Section 15 as follows:

6 (225 ILCS 106/15)

7 (Section scheduled to be repealed on January 1, 2016)

8 Sec. 15. Exemptions.

9 (a) This Act does not prohibit a person legally regulated 10 in this State by any other Act from engaging in any practice 11 for which he or she is authorized.

(b) Nothing in this Act shall prohibit the practice of respiratory care by a person who is employed by the United States government or any bureau, division, or agency thereof while in the discharge of the employee's official duties.

16 (c) Nothing in this Act shall be construed to limit the 17 activities and services of a person enrolled in an approved course of study leading to a degree or certificate of registry 18 19 or certification eligibility in respiratory care if these 20 activities and services constitute a part of a supervised 21 course of study and if the person is designated by a title 22 which clearly indicates his or her status as a student or trainee. Status as a student or trainee shall not exceed 3 23

1 years from the date of enrollment in an approved course.

2 (d) Nothing in this Act shall prohibit a person from 3 treating ailments by spiritual means through prayer alone in 4 accordance with the tenets and practices of a recognized church 5 or religious denomination.

6 (e) Nothing in this Act shall be construed to prevent a 7 person who is a registered nurse, an advanced practice nurse, a 8 licensed practical nurse, a physician assistant, or a physician 9 licensed to practice medicine in all its branches from 10 providing respiratory care.

(f) Nothing in this Act shall limit a person who is credentialed by the National Society for Cardiopulmonary Technology or the National Board for Respiratory Care from performing pulmonary function tests and respiratory care procedures related to the pulmonary function test.

16 (g) Nothing in this Act shall prohibit the collection and 17 analysis of blood by clinical laboratory personnel meeting the 18 personnel standards of the Illinois Clinical Laboratory Act.

19 (h) Nothing in this Act shall prohibit a polysomnographic 20 technologist, technician, or trainee, as defined in the job descriptions jointly accepted by the American Academy of Sleep 21 22 Medicine, the Association of Polysomnographic Technologists, 23 the Board of Registered Polysomnographic Technologists, and the American Society of Electroneurodiagnostic Technologists, 24 25 from performing activities within the scope of practice of polysomnographic technology while under the direction of a 26

1 physician licensed in this State.

2 (i) Nothing in this Act shall prohibit a family member from
3 providing respiratory care services to an ill person.

(j) Nothing in this Act shall be construed to limit an 4 5 unlicensed practitioner in a licensed hospital who is working under the proximate supervision of a licensed health care 6 7 professional or other authorized licensed personnel and 8 providing direct patient care services from performing basic 9 respiratory care activities if the unlicensed practitioner (i) 10 has been trained to perform the basic respiratory care 11 activities at the facility that employs or contracts with the 12 individual and (ii) at a minimum, has annually received an 13 evaluation of the unlicensed practitioner's performance of 14 basic respiratory care activities documented by the facility.

15 (k) Nothing in this Act shall be construed to prohibit a 16 person enrolled in a respiratory care education program or an 17 approved course of study leading to a degree or certification in a health care-related discipline that provides respiratory 18 care activities within his or her scope of practice and 19 20 employed in a licensed hospital in order to provide direct patient care services under the direction of other authorized 21 22 licensed personnel from providing respiratory care activities. 23 (Source: P.A. 94-523, eff. 1-1-06.)
