2	AMENDMENT NO Amend House Bill 1915 by replacing
3	everything after the enacting clause with the following:
4	"Section 5. The Child Passenger Protection Act is amended
5	by changing Section 6a as follows:

7	Sec. 6a. Child passenger safety instructional course.
8	(a) As used in this Section, "technician" means a person
9	who has successfully completed the U.S. Department of
10	Transportation National Highway Traffic Safety
11	Administration's (NHTSA) standardized National Child Passenger
12	Safety Certification Training Program and who maintains a
13	current child passenger safety technician or technician
14	instructor certification through the current certifying body
15	for the National Child Passenger Safety Training Program as
16	designated by the NHTSA.

1 (b) A person in violation of Section 4 of this Act may schedule a child safety instructional course with a technician. 2 The instructional course shall include instruction on the 3 4 proper installation of a child restraint system. The 5 instructional course shall also include an inspection of the child restraint system. At the time of scheduling, the 6 7 technician shall notify the person that the instructional course must be completed prior to the mandatory court 8 appearance date on the person's citation for a violation of 9 10 Section 4 of this Act.

(c) Prior to beginning the instructional course, the person must present a copy of the citation of a violation of Section 4 of this Act to the technician.

(d) The technician shall be observant for any citations with the notation "no safety seat" in the notes field and discuss with the person, for the purpose of determining the person's need for a child restraint system, the person's reasons for not transporting the child in a child restraint system.

20 (e) Upon completion of the instructional course to the 21 satisfaction of the technician conducting the course, the 22 technician shall issue a letter to the person for presentation 23 in court. The letter shall:

(1) be printed on <u>a form or in a manner required by the</u>
<u>Illinois Department of Transportation</u> the technician's
letterhead;

1 (2) indicate that the person has voluntarily 2 participated in the instructional course and received 3 instruction from a technician regarding the proper use of 4 the person's child restraint system; and

5 (3) include (i) the date the instructional course was 6 completed, (ii) the citation number presented to the 7 technician under this Section, (iii) the county in which 8 the citation was issued, and (iv) the technician's 9 signature and technician number.
