

1 AN ACT making appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The amount of \$38,660,300, or so much thereof  
6 as may be necessary, is appropriated from the General Revenue  
7 Fund to the Board of the Trustees of Chicago State University  
8 to meet ordinary and contingent expenses for the fiscal year  
9 ending June 30, 2010.

10 Section 10. In addition to any other amounts appropriated  
11 for such purposes, the following named amount, or so much  
12 thereof as may be necessary, is appropriated from the General  
13 Revenue Fund to the Board of Trustees of Chicago State  
14 University for the fiscal year beginning July 1, 2009,  
15 pursuant to Title XIV of the American Recovery and  
16 Reinvestment Act of 2009:

17 For Personal Services .....1,034,300

18 Section 15. In addition to any other amounts appropriated  
19 for such purposes, the following named amounts, or so much
