2 AMENDMENT NO. _____. Amend House Bill 2132, AS AMENDED,
3 by replacing everything after the enacting clause with the
4 following:

5 "ARTICLE 1

6 Section 5. The amount of \$38,660,300, or so much thereof
7 as may be necessary, is appropriated from the General Revenue
8 Fund to the Board of the Trustees of Chicago State University
9 to meet ordinary and contingent expenses for the fiscal year
10 ending June 30, 2010.

11 Section 10. In addition to any other amounts appropriated
12 for such purposes, the following named amount, or so much
13 thereof as may be necessary, is appropriated from the General
