1	which any licensee intending to organize as a limited liability					
2	company may incorporate as a professional corporation.					
3	Application for such registration shall be made in writing					
4	and shall contain the name and address of the limited liability					
5	company and such other information as may be required by the					
6	Department. Upon receipt of such application, the Department					
7	shall make an investigation of the limited liability company.					
8	If the Department finds that the organizers, managers, and					
9	members are each licensed pursuant to the laws of Illinois to					
10	engage in the particular profession or related professions					
11	involved (except that an initial organizer may be a licensed					
12	attorney) and if no disciplinary action is pending before the					
13	Department against any of them and if it appears that the					
14	limited liability company will be conducted in compliance with					
15	the law and the rules and regulations of the Department, the					
16	Department shall issue, upon payment of a registration fee of					
17	\$50, a certificate of registration.					
18	Upon written application of the holder, the Department					
19	shall renew the certificate if it finds that the limited					
20	liability company has complied with its regulations and the					
21	provisions of this Act and the applicable licensing Act. This					
22	fee for the renewal of a certificate of registration shall be					
23	calculated at the rate of \$40 per year. The certificate of					
24	registration shall be conspicuously posted upon the premises to					
25	which it is applicable, and the limited liability company shall					
26	have only those offices which are designated by street address
