Be it enacted by the People of the State of Illinois, represented in the General Assembly:

ARTICLE 1

The following named amounts, or so much 5 Section 5. thereof as may be necessary, respectively, for the objects 6 7 and purposes hereinafter named, are appropriated to the Board of the Trustees of Southern Illinois University to meet 8 ordinary and contingent expenses for the fiscal year ending 9 June 30, 2010: 10 Payable from the General Revenue Fund: 11 12 For Personal Services, including payment to the university for personal services 13 14 costs incurred during the fiscal year and salaries accrued but unpaid to academic 15 personnel for personal services rendered 16
