Section 20. The sum of \$185,000, or so much thereof as 7 8 may be necessary, is appropriated from the Illinois 9 Firefighters' Memorial Fund to the Office of the State Fire Marshal for expenses related to the maintenance of 10 the Illinois Firefighters' Memorial, holding the annual Fallen 11 Firefighter Ceremony, and other expenses as allowed under 12 Public Act 91-0832. 13

6 Section 35. The sum of \$1,000, or so much thereof as may 7 be necessary, is appropriated from the Fire Prevention Fund 8 to the Office of the State Fire Marshal for grants available 9 for the development of new fire districts.

10 Section 40. The sum of \$550,000, or so much thereof as 11 may be necessary, is appropriated from the Underground 12 Storage Tank Fund to the Office of the State Fire Marshal for 13 a grant to the City of Chicago for Administrative Costs 14 incurred as a result of the State's Underground Storage 15 Program.

16 Section 45. The sum of \$125,000, or so much thereof as 17 may be necessary, is appropriated from the Fire Prevention 18 Fund to the Office of the State Fire Marshal for grants 19 available for costs and services related to ILEAS/MABAS 20 administration.

21 Section 50. The sum of \$25,000, or so much thereof as

4 Section 55. The sum of \$5,000, or so much thereof as may 5 be necessary, is appropriated from the Cigarette Fire Safety 6 Standard Fund to the Office of the State Fire Marshal for the 7 purpose of fire safety and prevention programs.

8 Section 60. The sum of \$2,000,000, or so much thereof as 9 may be necessary, is appropriated from the Fire Service and 10 Small Equipment Fund to the Office of the State Fire Marshal 11 for the purpose of providing small equipment grants.

Section 99. Effective date. This Act takes effect July 1,2009.
