Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- 4 Section 10. The amount of \$325,000, or so much of that
- 5 amount as may be necessary, is appropriated from the Court of
- 6 Claims Administration and Grant Fund to the Court of Claims
- 7 for administrative expenses under the Crime Victims
- 8 Compensation Act.
- 9 Section 15. The amount of \$500,000, or so much of that
- 10 amount as may be necessary, is appropriated from the General
- 11 Revenue Fund to the Court of Claims for payment of awards
- 12 solely as a result of the lapsing of an appropriation
- originally made from any funds held by the State Treasurer.
- Section 20. The sum of \$13,000,000 or so much thereof as
- 15 may be necessary, is appropriated from the General Revenue
- 16 Fund to the Court of Claims for payment of line of duty
- awards.
- 18 Section 25. The following named amounts, or so much of
- 19 that amount as may be necessary, are appropriated to the

Section 99. Effective date. This Act takes effect July 1, 2009.
