The State agencies shall take into 8 consideration any recommendations made by the Council. 9 (q) The Council shall report to the General Assembly and the Governor annually, or as it deems necessary, regarding 10 11 proposed or recommended changes to State-implemented health 12 care plans and any associated costs of those changes. 13 (h) The Department of Public Health shall provide staff and 14 administrative support to the Council.
