SYNOPSIS AS INTRODUCED:

30 ILCS 105/6z-32

Amends the State Finance Act. Provides that conservation practice cost-share grants from the Partners for Conservation Fund may be made to livestock operations. Effective July 1, 2010.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- 7 Sec. 6z-32. Partners for Planning and Conservation.
- 8 (a) The Partners for Conservation Fund (formerly known as the Conservation 2000 Fund) and the Partners for Conservation Projects Fund (formerly known as the Conservation 2000 Projects 10 11 Fund) are created as special funds in the State Treasury. These funds shall be used to establish a comprehensive program to 12 13 protect Illinois' natural resources through cooperative 14 partnerships between State government and public and private landowners. Moneys in these Funds may be used, subject to 15 16 appropriation, by the Department of Natural 17 Environmental Protection Agency, and the Department purposes relating to 18 Agriculture for natural 19 protection, planning, recreation, tourism, and compatible 20 agricultural and economic development activities. Without 21 limiting these general purposes, moneys in these Funds may be 22 used, subject to appropriation, for the following specific

- (1) To foster sustainable agriculture practices and control soil erosion and sedimentation, including grants to Soil and Water Conservation Districts for conservation practice cost-share grants and grants to livestock operations for water quality protection and improvement, and for personnel, educational, and administrative expenses.
- (2) To establish and protect a system of ecosystems in public and private ownership through conservation easements, incentives to public and private landowners, natural resource restoration and preservation, water quality protection and improvement, land use and watershed planning, technical assistance and grants, and land acquisition provided these mechanisms are all voluntary on the part of the landowner and do not involve the use of eminent domain.
- (3) To develop a systematic and long-term program to effectively measure and monitor natural resources and ecological conditions through investments in technology and involvement of scientific experts.
- (4) To initiate strategies to enhance, use, and maintain Illinois' inland lakes through education, technical assistance, research, and financial incentives.
- (5) To partner with private landowners and with units of State, federal, and local government and with not-for-profit organizations in order to integrate State

(b) The State Comptroller and State Treasurer shall automatically transfer on the last day of each month, beginning on September 30, 1995 and ending on June 30, 2021, from the General Revenue Fund to the Partners for Conservation Fund, an amount equal to 1/10 of the amount set forth below in fiscal year 1996 and an amount equal to 1/12 of the amount set forth below in each of the other specified fiscal years:

(c) Notwithstanding any other provision of law to the contrary and in addition to any other transfers that may be provided for by law, on the last day of each month beginning on July 31, 2006 and ending on June 30, 2007, or as soon

- direct and the State Treasurer shall transfer \$1,000,000 from
- 3 the Open Space Lands Acquisition and Development Fund to the
- 4 Conservation 2000 Fund.
