AN ACT concerning criminal law.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The Criminal Code of 1961 is amended by changing
Section 8-2 as follows:

- 6 (720 ILCS 5/8-2) (from Ch. 38, par. 8-2)
- 7 Sec. 8-2. Conspiracy.

8 (a) Elements of <u>the</u> the offense. A person commits the 9 offense of conspiracy when, with intent that an offense be 10 committed, he or she agrees with another to the commission of 11 that offense. No person may be convicted of conspiracy to 12 commit an offense unless an act in furtherance of that 13 agreement is alleged and proved to have been committed by him 14 or her or by a co-conspirator.

(b) Co-conspirators. It is not a defense to conspiracy that the person or persons with whom the accused is alleged to have conspired:

- 18 (1) have not been prosecuted or convicted,
 19 (2) have been convicted of a different offense,
 20 (3) are not amenable to justice,
 21 (4) have been acquitted, or
- 22 (5) lacked the capacity to commit an offense.
