A BILL FOR

1 AN ACT making appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 Section 5. The following named amounts, or so much
5 thereof as may be necessary, respectively, are appropriated
6 to the Court of Claims for its ordinary and contingent
7 expenses:

4 Section 10. The amount of \$325,000, or so much of that
5 amount as may be necessary, is appropriated from the Court of
6 Claims Administration and Grant Fund to the Court of Claims
7 for administrative expenses under the Crime Victims
8 Compensation Act.

10 Section 15. The following named amounts, or so much of
11 that amount as may be necessary, are appropriated to the
12 Court of Claims for payment of claims as follows:

17 Section 20. The amount of \$500,000, or so much of that
18 amount as may be necessary, is appropriated from the General
19 Revenue Fund to the Court of Claims for payment of awards
20 solely as a result of the lapsing of an appropriation
21 originally made from any funds held by the State Treasurer.

22 Section 25. The sum of \$14,000,000 or so much thereof as

1 may be necessary, is appropriated from the General Revenue
 2 Fund to the Court of Claims for payment of line of duty
 3 awards.

4 Section 30. The following named amounts, or so much of
 5 that amount as may be necessary, are appropriated to the
 6 Court of Claims for payment of claims as follows:

7 For claims under the Crime Victims

8 Compensation Act:

9 Payable from General Revenue

10 Fund\$27,000,000

11 For claims other than Crime Victims:

12 Payable from the General

13 Revenue Fund10,000,000
