2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 may be necessary, is appropriated from the Illinois Historic
5 Sites Fund to the Historic Preservation Agency for awards and
6 grants for historic preservation programs made either
7 independently or in cooperation with the Federal Government
8 or any agency thereof, any municipal corporation, or
9 political subdivision of the State, or with any public or
10 private corporation, organization, or individual.

11 Section 25. The sum of \$411,300, or so much thereof as
12 may be necessary and remains unexpended at the close of
13 business on June 30, 2010, from appropriations heretofore
14 made for such purpose in Article 20, Sections 20 and 25 of
15 Public Act 95-731, is reappropriated from the Illinois
16 Historic Sites Fund to the Historic Preservation Agency for
17 awards and grants for historic preservation programs made
18 either independently or in cooperation with the Federal
19 Government or any agency thereof, any municipal corporation,
20 or political subdivision of the State, or with any public or
21 private corporation, organization, or individual.

11 Section 50. The sum of \$600,000, or so much thereof as
 12 may be necessary, is appropriated from the Illinois Historic
 13 Sites Fund to the Historic Preservation Agency for
 14 operations, maintenance, repairs, permanent improvements,
 15 special events, and all other costs related to the operation
 16 of Illinois Historic Sites and only to the extent which
 17 donations are received at Illinois State Historic Sites.

18 Section 55. The sum of \$0, or so much thereof as may be
 19 necessary, is appropriated to the Historic Preservation
 20 Agency from the General Revenue Fund for programs and
 21 purposes including repairing, maintaining, reconstructing,
 22 rehabilitating, replacing, fixed assets, construction and
 23 development, studies, all costs for supplies, materials,

1 labor, land acquisition and its related costs, services and
2 other expenses at historic sites.

3 Section 60. The sum of \$279,100, or so much thereof as
4 may be necessary, is appropriated from the General Revenue
5 Fund to the Historic Preservation Agency for the operational
6 expenses of the Lewis and Clark Historic Site in Madison
7 County.

8 Section 65. No contract shall be entered into or
9 obligation incurred for repairs and maintenance and other
10 capital improvements from appropriations made in Section 55
11 of this Article until after the purposes and amounts have
12 been approved in writing by the Governor.

13 Section 70. The following named sums, or so much thereof
14 as may be necessary, respectively, for the objects and
15 purposes hereinafter named, are appropriated to meet the
16 ordinary and contingent expenses of the Historic Preservation
