A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named sums, or so much thereof  
6 as may be necessary, respectively, for the objects and  
7 purposes hereinafter named, are appropriated to meet the  
8 ordinary and contingent expenses of the Department of  
9 Military Affairs:

22 Section 10. The sum of \$11,500,000, or so much thereof  
 23 as may be necessary, is appropriated from the Federal Support  
 24 Agreement Revolving Fund to the Department of Military

1     Affairs Facilities Division for expenses related to Army  
2     National Guard Facilities operations and maintenance as  
3     provided for in the Cooperative Funding Agreements, including  
4     costs in prior years.

5             Section 15. The sum of \$7,400, or so much thereof as may  
6     be necessary, is appropriated from the General Revenue Fund  
7     to the Department of Military Affairs Office of the Adjutant  
8     General Division for expenses related to the care and  
9     preservation of historic artifacts.

10            Section 20. The sum of \$3,000,000, or so much thereof as  
11     may be necessary, is appropriated from the Military Affairs  
12     Trust Fund to the Department of Military Affairs Office of  
13     the Adjutant General Division to support youth and other  
14     programs, provided such amounts shall not exceed funds to be  
15     made available from public or private sources.

16            Section 25. The sum of \$5,000,000, or so much thereof as  
17     may be necessary, is appropriated from the Illinois Military  
18     Family Relief Fund to the Department of Military Affairs  
19     Office of the Adjutant General Division for the issuance of  
20     grants to persons or families of persons who are members of  
21     the Illinois National Guard or Illinois residents who are  
22     members of the armed forces of the United States and who have

1     been called to active duty as a result of the September 11,  
2     2001 terrorist attacks, including costs in prior years.

3           Section 30. The sum of \$1,247,400, or so much thereof as  
4     may be necessary, is appropriated from the Federal Support  
5     Agreement Revolving Fund to the Department of Military  
6     Affairs Facilities Division for expenses for operations and  
7     maintenance according to Joint-Use Agreement, including costs  
8     in prior years.

9           Section 99. Effective date. This Act takes effect July 1,  
10    2010.
