7 WHEREAS, Under the guidance of Ross Centanni, Gardner 8 Denver moved from FORBES magazine's list of the 200 Best Small 9 Companies in America, to the 100 Best Mid-Cap Companies to 10 twice on the 100 Fastest Growing Companies and, most recently, 11 to two designations on The 400 Best Big Companies in America; 12 in 2006, Dow Jones & Company designated Gardner Denver as one of its highest rated stocks and the company was referred to in 13 the "SmartMoney Stock Screen" of the Wall Street Journal; 14 DeMarche Associates, Inc., one of the leading investment 15 16 research firms in the nation, also recognized Gardner Denver as being one of the 100 best companies in the United States, 17 putting it within the top 3 percent of all major U.S. 18 19 corporations; and
