1 WHEREAS, Deborah has been exceptionally involved in 2 community service and public policy at the local, State, and federal levels; she is the President of the Woods Fund of 3 Chicago, a Chicago-based foundation whose mission is to "give 4 5 voice to less advantaged people and communities"; as an appointee to the public policy advisory board of the National 6 7 Council on Foundations, she facilitated development of the Paul 8 Ylvisaker Award for Public Policy; she is a member of the 9 Mayoral Policy Caucus; she is a board member of the Donors 10 Forum of Chicago and an advisory board member of the Institute 11 of Government and Public Affairs at the University of Illinois; 12 she is Vice President of the board of Business and Professional 13 People for the Public Interest and serves as trustee to several other community-based, non-profit, and civic organizations; 14 and 15
