The Illinois Dental Practice Act is amended by 4 changing Sections 9 and 13 as follows: 5 6 (225 ILCS 25/9) (from Ch. 111, par. 2309) 7 (Section scheduled to be repealed on January 1, 2016) Sec. 9. Qualifications of Applicants for Dental Licenses. 8 The Department shall require that each applicant for a license 9 10 to practice dentistry shall: (a) (Blank). 11 12 (b) Be at least 21 years of age and of good moral 13 character. (c) (1) Present satisfactory evidence of completion of 14 15 dental education by graduation from a dental college or school

in the United States or Canada approved by the Department. The

Department shall not approve any dental college or school which does not require at least (A) 60 semester hours of collegiate credit or the equivalent in acceptable subjects from a college or university before admission, and (B) completion of at least 4 academic years of instruction or the equivalent in an approved dental college or school before graduation; or

(2) Present satisfactory evidence of completion of dental education by graduation from a dental college or school outside the United States or Canada and provide satisfactory evidence that:

(A) (blank);

- (B) the applicant has completed a minimum of 2 academic years of general dental clinical training at a dental college or school in the United States or Canada approved by the Department, however, an accredited advanced dental education program approved by the Department of no less than 2 years may be substituted for the 2 academic years of general dental clinical training and an applicant who was enrolled for not less than one year in an approved clinical program prior to January 1, 1993 at an Illinois dental college or school shall be required to complete only that program; and
- (C) the applicant has received certification from the dean of an approved dental college or school in the United States or Canada or the program director of an approved advanced dental education program stating that the

applicant has achieved the same level of scientific knowledge and clinical competence as required of all graduates of the college, school, or advanced dental education program.

Nothing in this Act shall be construed to prevent either the Department or any dental college or school from establishing higher standards than specified in this Act.

- (d) In determining professional capacity under this Section, any individual who has not been actively engaged in the practice of dentistry, has not been a dental student, or has not been engaged in a formal program of dental education during the 5 years immediately preceding the filing of an application may be required to complete such additional testing, training, or remedial education as the Board may deem necessary in order to establish the applicant's present capacity to practice dentistry with reasonable judgment, skill, and safety.
- (e) Present satisfactory evidence that the applicant has passed both parts of the National Board Dental Examination administered by the Joint Commission on National Dental Examinations and has successfully completed an examination conducted by one of the following regional testing services: the Central Regional Dental Testing Service, Inc. (CRDTS), the Southern Regional Testing Agency, Inc. (SRTA), the Western Regional Examining Board (WREB), or the North East Regional Board (NERB). For purposes of this Section, successful

completion shall mean that the applicant has achieved a minimum passing score as determined by the applicable regional testing service. Pass an examination authorized or given by the Department in the theory and practice of the science of dentistry; provided, that the Department (1) may recognize a certificate granted by the National Board of Dental Examiners in lieu of, or subject to, such examination as may be required and (2) may recognize successful completion of the clinical examination conducted by approved regional testing services in lieu of such examinations as may be required. For purposes of this Section, successful completion shall mean that the applicant has achieved a minimum passing score on the regional examinations as determined by each approved regional testing service.

13. Oualifications of Applicants for Hygienists. Every person who desires to obtain a license as a dental hygienist shall apply to the Department in writing, upon forms prepared and furnished by the Department. shall contain proof of application the particular qualifications required of the applicant, shall be verified by the applicant, under oath, and shall be accompanied by the required examination fee.

- 1 The Department shall require that every applicant for a 2 license as a dental hygienist shall:

- 4 (2) Be a graduate of high school or its equivalent.
- 5 (3) Present satisfactory evidence of having successfully 6 completed 2 academic years of credit at a dental hygiene program accredited by the Commission on Dental Accreditation of 7 the American Dental Association. 8
 - Submit evidence that he holds a currently valid certification to perform cardiopulmonary resuscitation. The Department shall adopt rules establishing criteria for certification in cardiopulmonary resuscitation. The rules of the Department shall provide for variances only in instances where the applicant is physically disabled and therefore unable to secure such certification.

- (6) Present satisfactory evidence that the applicant has 17 passed the National Board Dental Hygiene Examination 18 administered by the Joint Commission on National Dental 19 20 Examinations and has successfully completed an examination conducted by one of the following regional testing services: 21 22 the Central Regional Dental Testing Service, Inc. (CRDTS), the 23 Southern Regional Testing Agency, Inc. (SRTA), the Western 24 Regional Examining Board (WREB), or the North East Regional 25 Board (NERB). For the purposes of this Section, successful completion shall mean that the applicant has achieved a minimum 26

- passing score as determined by the applicable regional testing 1
- service. Pass an examination authorized or given by the 2
- Department in the subjects usually taught in approved programs 3
