1 AMENDMENT TO SENATE BILL 642

2 AMENDMENT NO. _____. Amend Senate Bill 642 as follows:

3 in Section 5, Sec. 7, subsec. (c), immediately above the
4 paragraph beginning "For the purposes", by inserting the
5 following:

6 "If the Board of Trustees exercises its power to borrow
7 money under this subsection (c), then the Board is prohibited
8 from using the proceeds of the debt issuance to pay any portion
9 of the salary of those University employees whose salaries
10 place them in the top 10% of wage earners at the University and
11 who are not members of a collective bargaining unit. However,
12 nothing in this subsection (c) prohibits the University from
13 using the proceeds of the debt issuance to pay any portion of
14 the salary of a University employee who is licensed to practice
15 medicine in all of its branches and is employed for the primary
16 purpose of practicing that profession at or for the
17 University."; and

1 in Section 10, Sec. 8, subdivision 13, immediately above the
2 paragraph beginning "For the purposes", by inserting the
3 following:

4 "If the Board exercises its power to borrow money under
5 this item 13, then the Board is prohibited from using the
6 proceeds of the debt issuance to pay any portion of the
7 salary of those University employees whose salaries place
8 them in the top 10% of wage earners at the University and
9 who are not members of a collective bargaining unit.
10 However, nothing in this item 13 prohibits the University
11 from using the proceeds of the debt issuance to pay any
12 portion of the salary of a University employee who is
13 licensed to practice medicine in all of its branches and is
14 employed for the primary purpose of practicing that
15 profession at or for the University."; and

16 in Section 15, Sec. 5-45, subdivision (13), immediately above
17 the paragraph beginning "For the purposes", by inserting the
18 following:

19 "If the Board exercises its power to borrow money under
20 this item (13), then the Board is prohibited from using the
21 proceeds of the debt issuance to pay any portion of the salary
22 of those University employees whose salaries place them in the
23 top 10% of wage earners at the University and who are not
24 members of a collective bargaining unit. However, nothing in

1 this item (13) prohibits the University from using the proceeds
2 of the debt issuance to pay any portion of the salary of a
3 University employee who is licensed to practice medicine in all
4 of its branches and is employed for the primary purpose of
5 practicing that profession at or for the University."; and

6 in Section 20, Sec. 10-45, subsec. (a), subdivision (12),
7 immediately above the paragraph beginning "For the purposes",
8 by inserting the following:

9 "If the Board exercises its power to borrow money under
10 this item (12), then the Board is prohibited from using the
11 proceeds of the debt issuance to pay any portion of the
12 salary of those University employees whose salaries place
13 them in the top 10% of wage earners at the University and
14 who are not members of a collective bargaining unit.
15 However, nothing in this item (12) prohibits the University
16 from using the proceeds of the debt issuance to pay any
17 portion of the salary of a University employee who is
18 licensed to practice medicine in all of its branches and is
19 employed for the primary purpose of practicing that
20 profession at or for the University."; and

21 in Section 25, Sec. 15-45, subdivision (13), immediately above
22 the paragraph beginning "For the purposes", by inserting the
23 following:

24 "If the Board exercises its power to borrow money under

1 this item (13), then the Board is prohibited from using the
2 proceeds of the debt issuance to pay any portion of the salary
3 of those University employees whose salaries place them in the
4 top 10% of wage earners at the University and who are not
5 members of a collective bargaining unit. However, nothing in
6 this item (13) prohibits the University from using the proceeds
7 of the debt issuance to pay any portion of the salary of a
8 University employee who is licensed to practice medicine in all
9 of its branches and is employed for the primary purpose of
10 practicing that profession at or for the University."; and

11 in Section 30, Sec. 20-45, subdivision (14), immediately above
12 the paragraph beginning "For the purposes", by inserting the
13 following:

14 "If the Board exercises its power to borrow money under
15 this item (14), then the Board is prohibited from using the
16 proceeds of the debt issuance to pay any portion of the salary
17 of those University employees whose salaries place them in the
18 top 10% of wage earners at the University and who are not
19 members of a collective bargaining unit. However, nothing in
20 this item (14) prohibits the University from using the proceeds
21 of the debt issuance to pay any portion of the salary of a
22 University employee who is licensed to practice medicine in all
23 of its branches and is employed for the primary purpose of
24 practicing that profession at or for the University."; and

1 in Section 33, Sec. 25-45, subdivision (13), immediately above
2 the paragraph beginning "For the purposes", by inserting the
3 following:

4 "If the Board exercises its power to borrow money under
5 this item (13), then the Board is prohibited from using the
6 proceeds of the debt issuance to pay any portion of the salary
7 of those University employees whose salaries place them in the
8 top 10% of wage earners at the University and who are not
9 members of a collective bargaining unit. However, nothing in
10 this item (13) prohibits the University from using the proceeds
11 of the debt issuance to pay any portion of the salary of a
12 University employee who is licensed to practice medicine in all
13 of its branches and is employed for the primary purpose of
14 practicing that profession at or for the University."; and

15 in Section 35, Sec. 30-45, subdivision (14), immediately above
16 the paragraph beginning "For the purposes", by inserting the
17 following:

18 "If the Board exercises its power to borrow money under
19 this item (14), then the Board is prohibited from using the
20 proceeds of the debt issuance to pay any portion of the salary
21 of those University employees whose salaries place them in the
22 top 10% of wage earners at the University and who are not
23 members of a collective bargaining unit. However, nothing in
24 this item (14) prohibits the University from using the proceeds
25 of the debt issuance to pay any portion of the salary of a

1 University employee who is licensed to practice medicine in all
2 of its branches and is employed for the primary purpose of
3 practicing that profession at or for the University."; and

4 in Section 40, Sec. 35-45, subdivision (13), immediately above
5 the paragraph beginning "For the purposes", by inserting the
6 following:

7 "If the Board exercises its power to borrow money under
8 this item (13), then the Board is prohibited from using the
9 proceeds of the debt issuance to pay any portion of the salary
10 of those University employees whose salaries place them in the
11 top 10% of wage earners at the University and who are not
12 members of a collective bargaining unit. However, nothing in
13 this item (13) prohibits the University from using the proceeds
14 of the debt issuance to pay any portion of the salary of a
15 University employee who is licensed to practice medicine in all
16 of its branches and is employed for the primary purpose of
17 practicing that profession at or for the University.".
