1 AMENDMENT TO SENATE BILL 737

2 AMENDMENT NO. _____. Amend Senate Bill 737, AS AMENDED,
3 with reference to page and line numbers of Senate Amendment No.
4 1 as follows:

5 on page 27, line 16, after "bonds.", by inserting "This
6 prohibition shall also apply to a company or firm that employs
7 a person holding an elective office in this State, holding a
8 seat in the General Assembly, or serving as a board member,
9 trustee, officer, or employee of the Authority, including the
10 spouse of that person, if the person or his or her spouse has
11 greater than 7.5% ownership of the company or firm."; and

12 on page 211, line 7, after "paid", by inserting "as follows:
13 0.33 1/3%"; and

14 on page 215, line 18, by replacing "Horse" with "Illinois
15 Horse"; and

1 on page 215, line 18, after "1975", by inserting "is
2 authorized"; and

3 on page 218, line 13, by deleting "land-based"; and

4 on page 253, line 2, by replacing "Additionally, the" with
5 "The"; and

6 on page 253, line 13, by deleting "from a home dock"; and

7 on page 254, lines 15 through 16, by replacing "amount for

10 on page 255, line 10, after "Act", by inserting "and issued
11 prior to the effective date of this amendatory Act of the 96th
12 General Assembly"; and

6 for licensees not located in Cook County and \$25,000 for
7 licensees located in Cook County, in addition to the
8 reconciliation payment, as set forth in (e-12), (e-16), or
9 (h-5). A licensee may operate"; and

6 subsection (i) of this Section"; and

7 on page 268, line 22, after "remodeling", by inserting "or
8 relocation"; and

9 on page 282, by replacing line 20 with "authorized under this
10 Section is subject to the"; and

11 on page 291, line 13, by replacing "or" with "on"; and

12 on page 292, line 1, by replacing "the \$1" with "\$1"; and

13 on page 292, immediately below line 4, by inserting the
14 following:

15 "From the tax imposed under this subsection (c-5) on an
16 electronic gaming facility that is located in an unincorporated
17 area of Cook County and has been awarded standardbred racing
18 dates during 2010 by the Illinois Racing Board, \$1 for each
19 person who enters the electronic gaming facility shall be

1 distributed as follows, subject to appropriation: \$0.50 to the
2 Village of Melrose Park and \$0.50 to Cook County."; and

3 on page 297, by deleting line 26; and

4 on page 298, by deleting lines 1 through 8; and

5 on page 298, by replacing lines 9 through 16 with the
6 following:

7 "From the effective date of this amendatory Act of the 96th
8 General Assembly until June 30, 2015, an owners licensee that
9 (i) is located within 15 miles of the Missouri border and (ii)
10 has at least 3 riverboats, casinos, or their equivalent within
11 a 45-mile radius, may be authorized to relocate to a new
12 location with the approval of the unit of local government that
13 was designated as the home dock of the riverboat on January 1,
14 2010 and with Board approval and shall receive a
15 dollar-for-dollar credit by the Board for any renovation or
16 construction costs paid by the owners licensee, but in no event
17 shall the credit exceed \$2,000,000."; and

18 on page 300, by replacing lines 5 through 8 with the following:

19 "(a-7) From January 1, 2013 until January 1, 2016, if the
20 total obligation imposed pursuant to either subsection (a-5) or
21 (a-6) will result in an owners licensee receiving less
22 after-tax adjusted gross receipts than it received in calendar

1 year 2012, then the"; and

2 on page 304, line 9, by deleting "or the City of Collinsville";
3 and

4 on page 304, by replacing lines 13 through 19 with the
5 following:

6 "facility is located, except as otherwise provided in this
7 Section. From the tax revenue deposited in the State Gaming
8 Fund under this Section, an amount equal to 3% of adjusted
9 gross receipts generated by each electronic gaming facility
10 that is located in an unincorporated area of Cook County and
11 has been awarded standardbred racing dates during 2010 by the
12 Illinois Racing Board shall be paid monthly, subject to
13 appropriation by the General Assembly, as follows: 50% to the

19 "From the tax revenue deposited in the State Gaming Fund

21 receipts generated by an electronic gaming facility located in
22 the City of Collinsville shall be paid monthly, subject to

1 appropriation by the General Assembly, as follows: 45% to the
2 City of Alton, 45% to the City of East St. Louis, and 10% to the
3 City of Collinsville."; and

4 on page 305, by replacing lines 4 through 8 with "(i) 1% of
5 adjusted"; and

6 on page 305, line 12, by replacing "(iii)" with "(ii)".
