American/Alaska Native, or Asian/Pacific Islander; 1 (2) the alleged traffic violation that led to the stop 2 3 of the motorist; (3) the make and year of the vehicle stopped; 4 5 (4) the date and time of the stop, beginning when the vehicle was stopped and ending when the driver is free to 6 leave or taken into physical custody; 7 8 (5) the location of the traffic stop; 9 (5.5) whether or not a consent search contemporaneous 10 to the stop was requested of the vehicle, driver, passenger, or passengers; and, if so, whether consent was 11 given or denied; 12 13 (6) whether or not a search contemporaneous to the stop 14 conducted of the vehicle, driver, passenger, or was 15 passengers; and, if so, whether it was with consent or by 16 other means: 17 (6.5) whether or not contraband was found during a 18 search; and, if so, the type and amount of contraband seized; and 19 20 (7) the name and badge number of the issuing officer. 21 (b) Whenever a State or local law enforcement officer stops 22 a motorist for an alleged violation of the Illinois Vehicle 23 Code and does not issue a uniform traffic citation or warning 24 citation for an alleged violation of the Illinois Vehicle Code, 25 he or she shall complete a uniform stop card, which includes 26 field contact cards, or any other existing form currently used

by law enforcement containing information required pursuant to this Act, that records at least the following:

3 (1) the name, address, gender, and the officer's
4 subjective determination of the race of the person stopped;
5 the person's race shall be selected from the following

7 American/Alaska Native, or Asian/Pacific Islander;

(2) the reason that led to the stop of the motorist;

(3) the make and year of the vehicle stopped;

10 (4) the date and time of the stop, beginning when the 11 vehicle was stopped and ending when the driver is free to 12 leave or taken into physical custody;

(5) the location of the traffic stop;

14 (5.5) whether or not a consent search contemporaneous 15 to the stop was requested of the vehicle, driver, 16 passenger, or passengers; and, if so, whether consent was 17 given or denied;

18 (6) whether or not a search contemporaneous to the stop 19 was conducted of the vehicle, driver, passenger, or 20 passengers; and, if so, whether it was with consent or by 21 other means;

(6.5) whether or not contraband was found during a search; and, if so, the type and amount of contraband seized; and

(7) the name and badge number of the issuing officer.(c) The Illinois Department of Transportation shall

provide a standardized law enforcement data compilation form on its website.

(d) Every law enforcement agency shall, by March 1 with 3 4 regard to data collected during July through December of the 5 previous calendar year and by August 1 with regard to data 6 collected during January through June of the current calendar year, compile the data described in subsections (a) and (b) on 7 8 the standardized law enforcement data compilation form 9 provided by the Illinois Department of Transportation and 10 transmit the data to the Department.

11 Illinois Department of Transportation shall (e) The analyze the data provided by law enforcement agencies required 12 13 by this Section and submit a report of the previous year's 14 findings to the Governor, the General Assembly, the Racial 15 Profiling Prevention and Data Oversight Board, and each law 16 enforcement agency no later than July 1 of each year. The Illinois Department of Transportation may contract with an 17 18 outside entity for the analysis of the data provided. In 19 analyzing the data collected under this Section, the analyzing 20 entity shall scrutinize the data for evidence of statistically 21 significant aberrations. The following list. which is 22 illustrative, and not exclusive, contains examples of areas in 23 which statistically significant aberrations may be found:

(1) The percentage of minority drivers or passengers
 being stopped in a given area is substantially higher than
 the proportion of the overall population in or traveling

through the area that the minority constitutes.

2 (2) A substantial number of false stops including stops
3 not resulting in the issuance of a traffic ticket or the
4 making of an arrest.

5 (3) A disparity between the proportion of citations 6 issued to minorities and proportion of minorities in the 7 population.

8 (4) A disparity among the officers of the same law 9 enforcement agency with regard to the number of minority 10 drivers or passengers being stopped in a given area.

(5) A disparity between the frequency of searches performed on minority drivers and the frequency of searches performed on non-minority drivers.

(f) Any law enforcement officer identification information 14 15 or driver identification information that is compiled by any 16 enforcement agency or the Illinois law Department of 17 Transportation pursuant to this Act for the purposes of 18 fulfilling the requirements of this Section shall be 19 confidential and exempt from public inspection and copying, as 20 provided under Section 7 of the Freedom of Information Act, and 21 the information shall not be transmitted to anyone except as 22 needed to comply with this Section. This Section shall not exempt those materials that, prior to the effective date of 23 24 this amendatory Act of the 93rd General Assembly, were 25 available under the Freedom of Information Act. This subsection 26 (f) shall not preclude law enforcement agencies from reviewing 09600SB0933sam001

1 data to perform internal reviews.

2 (g) Funding to implement this Section shall come from
3 federal highway safety funds available to Illinois, as directed
4 by the Governor.

5 The Illinois Department of Transportation, (h) in 6 consultation with law enforcement agencies, officials, and organizations, including Illinois chiefs of police, 7 the Department of State Police, the Illinois Sheriffs Association, 8 9 and the Chicago Police Department, and community groups and 10 other experts, shall undertake a study to determine the best 11 use of technology to collect, compile, and analyze the traffic stop statistical study data required by this Section. The 12 13 Department shall report its findings and recommendations to the Governor and the General Assembly by March 1, 2004. 14

(i) This Section is repealed on July 1, <u>2020</u> 2010.
