2	AMENDMENT NO Amend Senate Bill 934 by replacing
3	everything after the enacting clause with the following:
4	"Section 5. The State Finance Act is amended by adding
5	Section 5.755 as follows:
6	(30 ILCS 105/5.755 new)
7	Sec. 5.755. The Workers Memorial Construction and
8	Maintenance Fund.
9	Section 10. The Illinois Vehicle Code is amended by adding
10	Section 3-689 as follows:
11	(625 ILCS 5/3-689 new)
12	Sec. 3-689. Trade Union license plates.
13	(a) The Secretary, upon receipt of an application made in
14	the form prescribed by the Secretary, may issue special

- 1 registration plates designated as Trade Union license plates.
- The special plates issued under this Section shall be affixed 2
- only to passenger vehicles of the first division and motor 3
- 4 vehicles of the second division weighing not more than 8,000
- 5 pounds. Plates issued under this Section shall expire according
- 6 to the multi-year procedure established by Section 3-414.1 of
- 7 this Code.
- (b) The design and color of the plates is wholly within the 8
- 9 discretion of the Secretary. Appropriate documentation, as
- 10 determined by the Secretary, shall accompany each application.
- 11 The Secretary may allow the plates to be issued as vanity
- plates or personalized under Section 3-405.1 of the Code. The 12
- 13 Secretary shall prescribe stickers or decals as provided under
- Section 3-412 of this Code. The Secretary may, in his or her 14
- 15 discretion, allow the plates to be issued as vanity or
- 16 personalized plates in accordance with Section 3-405.1 of this
- 17 Code.
- (c) An applicant for the special plate shall be charged a 18
- 19 \$25 fee for original issuance in addition to the appropriate
- 20 registration fee. Of this fee, \$10 shall be deposited into the
- Workers Memorial Construction and Maintenance Fund and \$15 21
- 22 shall be deposited into the Secretary of State Special License
- 23 Plate Fund, to be used by the Secretary to help defray the
- 24 administrative processing costs.
- 25 For each registration renewal period, a \$25 fee, in
- addition to the appropriate registration fee, shall be charged. 26

- 2 Construction and Maintenance Fund and \$2 shall be deposited
- 3 into the Secretary of State Special License Plate Fund.
- 4 (d) The Workers Memorial Construction and Maintenance Fund
- 5 is created as a special fund in the State treasury. All money
- 6 in the Workers Memorial Construction and Maintenance Fund shall
- 7 be paid, subject to appropriation, as grants for the
- construction and maintenance of worker memorials throughout 8
- 9 the State of Illinois.".
