1 AMENDMENT TO SENATE BILL 1197

2 AMENDMENT NO. \_\_\_\_\_. Amend Senate Bill 1197, by  
3 replacing everything after the enacting clause with the  
4 following:

5 "ARTICLE 1

6 Section 5. "Operational expenses" defined. For the  
7 purposes of this amendatory Act of the 96<sup>th</sup> General Assembly,  
8 the term "operational expenses" includes the following items:

- 9 (a) Personal services;
- 10 (b) State contributions to Social Security;
- 11 (c) Group Insurance;
- 12 (d) Contractual services, except that professional and  
13 artistic services shall not be included in the definition of  
14 "operational expenses";

- 1 (e) Travel;
- 2 (f) Commodities;
- 3 (g) Printing;
- 4 (h) Equipment;
- 5 (i) Electronic data processing;
- 6 (j) Telecommunications services;
- 7 (k) Operation of automotive equipment;
- 8 (l) Refunds.

9 Section 10. "Professional and artistic services" defined.  
10 For the purposes of this amendatory Act of the 96<sup>th</sup> General  
11 Assembly, the term "professional and artistic services" means  
12 those services provided under contract to a State agency by a  
13 person or business, acting as an independent contractor,  
14 qualified by education, experience, and technical ability.

15 ARTICLE 2

16 Section 25. In addition to other amounts appropriated,  
17 the amount of \$371,000, or so much thereof as may be  
18 necessary, is appropriated from the General Revenue Fund to  
19 the Legislative Information System for operational expenses,  
20 awards, grants, and permanent improvements for the fiscal  
21 year ending June 30, 2010, except that no amounts may be  
22 expended for professional and artistic services. No money may

1 be transferred into or out of this line item.

2 ARTICLE 3

3 Section 25. In addition to other amounts appropriated,  
4 the amount of \$36,485,500, or so much thereof as may be  
5 necessary, is appropriated from the General Revenue Fund to  
6 the Supreme Court for operational expenses, awards, grants,  
7 and permanent improvements for the fiscal year ending June  
8 30, 2010, except that no amounts may be expended for  
9 professional and artistic services. No money may be  
10 transferred into or out of this line item.

11 ARTICLE 4

12 Section 25. In addition to other amounts appropriated,  
13 the amount of \$407,200, or so much thereof as may be  
14 necessary, is appropriated from the General Revenue Fund to  
15 the Office of the State Appellate Defender for operational  
16 expenses, awards, grants, state matching grant purposes, and  
17 permanent improvements for the fiscal year ending June 30,  
18 2010, except that no amounts may be expended for professional  
19 and artistic services. No money may be transferred into or  
20 out of this line item.

ARTICLE 5

2

Section 25. In addition to other amounts appropriated,  
 3 the amount of \$1,993,300, or so much thereof as may be  
 4 necessary, is appropriated from the General Revenue Fund to  
 5 the Office of the State's Attorneys Appellate Prosecutor for  
 6 operational expenses, awards, grants, state matching grant  
 7 purposes, and permanent improvements for the fiscal year  
 8 ending June 30, 2010, except that no amounts may be expended  
 9 for professional and artistic services. No money may be  
 10 transferred into or out of this line item.

Section 25. In addition to other amounts appropriated,  
 20 the amount of \$16,761,600, or so much thereof as may be  
 21 necessary, is appropriated from the General Revenue Fund to

1 the Court of Claims for operational expenses, awards, grants,  
2 and permanent improvements for the fiscal year ending June  
3 30, 2010, except that no amounts may be expended for  
4 professional and artistic services. No money may be  
5 transferred into or out of this line item.

6 ARTICLE 7

7 Section 25. In addition to other amounts appropriated,  
8 the amount of \$1,887,500, or so much thereof as may be  
9 necessary, is appropriated from the General Revenue Fund to  
10 the Office of the Attorney General for operational expenses,  
11 awards, grants, and permanent improvements for the fiscal  
12 year ending June 30, 2010, except that no amounts may be  
13 expended for professional and artistic services. No money may  
14 be transferred into or out of this line item.

15 ARTICLE 8

16 Section 25. In addition to other amounts appropriated,  
17 the amount of \$15,667,800, or so much thereof as may be  
18 necessary, is appropriated from the General Revenue Fund to  
19 the Office of the Secretary of State for operational  
20 expenses, awards, grants, and permanent improvements for the  
21 fiscal year ending June 30, 2010, except that no amounts may

1 be expended for professional and artistic services. No money  
2 may be transferred into or out of this line item.

3 Section 30. The amount of \$130,500,000, or so much  
4 thereof as may be necessary, is appropriated from the General  
5 Revenue Fund to the Secretary of State for the purpose of  
6 replacing spending previously appropriated from the Road  
7 Fund.

8 ARTICLE 9

9 Section 25. In addition to other amounts appropriated,  
10 the amount of \$8,500,000, or so much thereof as may be  
11 necessary, is appropriated from the General Revenue Fund to  
12 the Office of the State Treasurer for operational expenses,  
13 awards, grants, and permanent improvements for the fiscal  
14 year ending June 30, 2010, except that no amounts may be  
15 expended for professional and artistic services. No money may  
16 be transferred into or out of this line item.

17 ARTICLE 10

18 Section 25. In addition to other amounts appropriated,  
19 the amount of \$6,130,700, or so much thereof as may be  
20 necessary, is appropriated from the General Revenue Fund to

1 the State Board of Elections for operational expenses,  
2 awards, grants, and permanent improvements for the fiscal  
3 year ending June 30, 2010, except that no amounts may be  
4 expended for professional and artistic services. No money may  
5 be transferred into or out of this line item.

6 ARTICLE 11

7 Section 25. In addition to other amounts appropriated,  
8 the amount of \$306,473,400, or so much thereof as may be  
9 necessary, is appropriated from the General Revenue Fund to  
10 the Department on Aging for operational expenses, awards,  
11 grants, and permanent improvements for the fiscal year ending  
12 June 30, 2010, except that no amounts may be expended for  
13 professional and artistic services. No money may be  
14 transferred into or out of this line item.

15 ARTICLE 12

16 Section 25. In addition to other amounts appropriated,  
17 the amount of \$9,337,300, or so much thereof as may be  
18 necessary, is appropriated from the General Revenue Fund to  
19 the Department of Agriculture for operational expenses,  
20 awards, grants, and permanent improvements for the fiscal  
21 year ending June 30, 2010, except that no amounts may be

1 expended for professional and artistic services. No money may  
2 be transferred into or out of this line item.

3 ARTICLE 13

4 Section 25. In addition to other amounts appropriated,  
5 the amount of \$8,425,500, or so much thereof as may be  
6 necessary, is appropriated from the General Revenue Fund to  
7 the Central Management Services for operational expenses,  
8 awards, grants, and permanent improvements for the fiscal  
9 year ending June 30, 2010, except that no amounts may be  
10 expended for professional and artistic services. No money may  
11 be transferred into or out of this line item.

12 ARTICLE 14

13 Section 25. In addition to other amounts appropriated,  
14 the amount of \$314,331,900, or so much thereof as may be  
15 necessary, is appropriated from the General Revenue Fund to  
16 the Department of Children and Family Services for  
17 operational expenses, awards, grants, and permanent  
18 improvements for the fiscal year ending June 30, 2010, except  
19 that no amounts may be expended for professional and artistic  
20 services. No money may be transferred into or out of this  
21 line item.

## ARTICLE 15

2           Section 25. In addition to other amounts appropriated,  
3 the amount of \$18,503,500, or so much thereof as may be  
4 necessary, is appropriated from the General Revenue Fund to  
5 the Department of Commerce and Economic Opportunity for  
6 operational expenses, awards, grants, and permanent  
7 improvements for the fiscal year ending June 30, 2010, except  
8 that no amounts may be expended for professional and artistic  
9 services. No money may be transferred into or out of this  
10 line item.

## ARTICLE 16

12           Section 25. In addition to other amounts appropriated,  
13 the amount of \$1,173,400, or so much thereof as may be  
14 necessary, is appropriated from the General Revenue Fund to

6           year ending June 30, 2010, except that no amounts may be  
7           expended for professional and artistic services. No money may  
8           be transferred into or out of this line item.

## ARTICLE 18

10           Section 25. In addition to other amounts appropriated,  
11           the amount of \$13,468,000, or so much thereof as may be  
12           necessary, is appropriated from the General Revenue Fund to  
13           the Department of Corrections for operational expenses,  
14           awards, grants, and permanent improvements for the fiscal  
15           year ending June 30, 2010, except that no amounts may be  
16           expended for professional and artistic services. No money may  
17           be transferred into or out of this line item.

## ARTICLE 19

19           Section 25. In addition to other amounts appropriated,  
20           the amount of \$1,337,700, or so much thereof as may be

1 necessary, is appropriated from the General Revenue Fund to  
2 the Department of Human Rights for operational expenses,  
3 awards, grants, and permanent improvements for the fiscal  
4 year ending June 30, 2010, except that no amounts may be  
5 expended for professional and artistic services. No money may  
6 be transferred into or out of this line item.

8 Section 25. In addition to other amounts appropriated,  
9 the amount of \$6,907,700, or so much thereof as may be  
10 necessary, is appropriated from the General Revenue Fund to  
11 the Department of Employment Security for operational  
12 expenses, awards, grants, and permanent improvements for the  
13 fiscal year ending June 30, 2010, except that no amounts may  
14 be expended for professional and artistic services. No money  
15 may be transferred into or out of this line item.

## ARTICLE 21

17 Section 25. In addition to other amounts appropriated,  
18 the amount of \$1,666,616,900, or so much thereof as may be  
19 necessary, is appropriated from the General Revenue Fund to  
20 the Department of Human Services for operational expenses,  
21 awards, grants, and permanent improvements for the fiscal

1 year ending June 30, 2010, except that no amounts may be  
2 expended for professional and artistic services. No money may  
3 be transferred into or out of this line item.

4 ARTICLE 22

5 Section 25. In addition to other amounts appropriated,  
6 the amount of \$129,800, or so much thereof as may be  
7 necessary, is appropriated from the General Revenue Fund to  
8 the Department of Labor for operational expenses, awards,  
9 grants, and permanent improvements for the fiscal year ending  
10 June 30, 2010, except that no amounts may be expended for  
11 professional and artistic services. No money may be  
12 transferred into or out of this line item.

13 ARTICLE 23

14 Section 25. In addition to other amounts appropriated,  
15 the amount of \$1,128,700, or so much thereof as may be  
16 necessary, is appropriated from the General Revenue Fund to  
17 the Department of Military Affairs for operational expenses,  
18 awards, grants, and permanent improvements for the fiscal  
19 year ending June 30, 2010, except that no amounts may be  
20 expended for professional and artistic services. No money may  
21 be transferred into or out of this line item.

## ARTICLE 24

2           Section 25. In addition to other amounts appropriated,  
3 the amount of \$1,979,752,900, or so much thereof as may be  
4 necessary, is appropriated from the General Revenue Fund to  
5 the Department of Healthcare and Family Services for  
6 operational expenses, awards, grants, and permanent  
7 improvements for the fiscal year ending June 30, 2010, except  
8 that no amounts may be expended for professional and artistic  
9 services. No money may be transferred into or out of this  
10 line item.

11           Section 30. For the fiscal year beginning on July 1,  
12 2009, the Department of Healthcare and Family Services, with  
13 the consent in writing from the Governor, may reapportion not  
14 more than 4% of the total General Revenue Fund appropriations  
15 to the Department for Medical Assistance, as contained in any  
16 Act of the 96<sup>th</sup> General Assembly, among the various purposes  
17 therein enumerated.

## ARTICLE 25

19           Section 25. In addition to other amounts appropriated,  
20 the amount of \$45,728,100, or so much thereof as may be

1 necessary, is appropriated from the General Revenue Fund to  
2 the Department of Public Health for operational expenses,  
3 awards, grants, and permanent improvements for the fiscal  
4 year ending June 30, 2010, except that no amounts may be  
5 expended for professional and artistic services. No money may  
6 be transferred into or out of this line item.

7

## ARTICLE 26

8 Section 25. In addition to other amounts appropriated,  
9 the amount of \$17,438,300, or so much thereof as may be  
10 necessary, is appropriated from the General Revenue Fund to  
11 the Department of Revenue for operational expenses, awards,  
12 grants, and permanent improvements for the fiscal year ending  
13 June 30, 2010, except that no amounts may be expended for  
14 professional and artistic services. No money may be  
15 transferred into or out of this line item.

16

## ARTICLE 27

17 Section 25. In addition to other amounts appropriated,  
18 the amount of \$5,841,500, or so much thereof as may be  
19 necessary, is appropriated from the General Revenue Fund to  
20 the Illinois State Police for operational expenses, awards,  
21 grants, and permanent improvements for the fiscal year ending

1 June 30, 2010, except that no amounts may be expended for  
2 professional and artistic services. No money may be  
3 transferred into or out of this line item.

4 Section 30. The amount of \$105,584,500, or so much  
5 thereof as may be necessary, is appropriated from the General  
6 Revenue Fund to the Illinois State Police for the purpose of  
7 replacing spending previously appropriated from the Road  
8 Fund.

9 ARTICLE 28

10 Section 25. In addition to other amounts appropriated,  
11 the amount of \$33,141,600, or so much thereof as may be  
12 necessary, is appropriated from the General Revenue Fund to  
13 the Department of Transportation for operational expenses,  
14 awards, grants, and permanent improvements for the fiscal  
15 year ending June 30, 2010, except that no amounts may be  
16 expended for professional and artistic services. No money may  
17 be transferred into or out of this line item.

18 ARTICLE 29

19 Section 25. In addition to other amounts appropriated,  
20 the amount of \$1,990,500, or so much thereof as may be

1 necessary, is appropriated from the General Revenue Fund to  
2 the Department of Veterans' Affairs for operational expenses,  
3 awards, grants, and permanent improvements for the fiscal  
4 year ending June 30, 2010, except that no amounts may be  
5 expended for professional and artistic services. No money may  
6 be transferred into or out of this line item.
