2 AMENDMENT NO. _____. Amend Senate Bill 1235, AS AMENDED, by
3 deleting everything after the enacting clause and inserting
4 in lieu thereof the following:

5 "ARTICLE 1

6 Section 5. "AN ACT concerning appropriations", Public
7 Act 96-042, approved July 15, 2009, as amended by P.A. 96-
8 819, is amended by changing Sections 5, 10, 15, 25 and 45 to
9 Article 60 as follows:

6 Sec. 25. In addition to other amounts appropriated, the
7 amount of \$333,669,200 ~~\$370,743,600~~, or so much thereof as
8 may be necessary, is appropriated from the General Revenue
9 Fund to the Illinois State Board of Education for operational
10 expenses, awards, grants, and permanent improvements for the
11 fiscal year ending June 30, 2010.

13 Sec. 45. The amount of \$8,190,000 ~~9,100,000~~, or so much
14 thereof as may be necessary, is appropriated from the Common
15 School Fund to the Illinois State Board of Education for
16 Regional Superintendents' and Assistants' compensation.

17 Section 99. Effective date. This Act takes effect upon
18 becoming law."
