4	pari-mutuel tax imposed on advance deposit wagering by this
5	amendatory Act of the 96th General Assembly shall be deposited
6	into the Quarter Horse Purse Fund, which shall be created as a
7	non-appropriated trust fund administered by the Board for
8	grants to thoroughbred organization licensees for payment of
9	purses for quarter horse races conducted by the organization
