Makes appropriations and reappropriations to the University of Illinois for various purposes, including for ordinary and contingent expenses. Effective July 1, 2009.

A BILL FOR

1 AN ACT making appropriations and reappropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 Section 5. The following named amounts, or so much
5 thereof as may be necessary, respectively, for the objects
6 and purposes hereinafter named, are appropriated to the Board
7 of the Trustees of the University of Illinois to meet
8 ordinary and contingent expenses for the fiscal year ending
9 June 30, 2010:

10 Payable from the General Revenue Fund:

11	For Personal Services, including payment	
12	to the university for personal services	
13	costs incurred during the fiscal year	
14	and salaries accrued but unpaid to academic	
15	personnel for personal services rendered

Section 10. The sum of \$15,826,500, or so much thereof as may be necessary, is appropriated from the General Revenue Fund to the Board of Trustees of the University of Illinois for operating costs and expenses related to or in support of the Institute of Natural Resource Sustainability, in accordance with Public Act 95-728.

Section 15. The sum of \$2,445,500, or so much thereof as may be necessary, is appropriated from the Fire Prevention Fund to the Board of Trustees of the University of Illinois for the purpose of maintaining the Illinois Fire Service Institute, paying the Institute's expenses, and providing the facilities and structures incident thereto, including payment

1 to the University for personal services and related costs
2 incurred.

3 Section 20. The sum of \$250,000, or so much thereof as
4 may be necessary, is appropriated from the State College and
5 University Trust Fund to the Board of Trustees of the
6 University of Illinois for scholarship grant awards, in
7 accordance with Public Act 91-83.

8 Section 25. The sum of \$1,000,000, or so much thereof as
9 may be necessary, is appropriated from the General Revenue
10 Fund to the University of Illinois for the Complete Help and
11 Assistance Necessary for a College Education (C.H.A.N.C.E)
12 program at the Office of School Relations at the Chicago
13 campus.

14 Section 30. The sum of \$800,000, or so much thereof as
15 may be necessary, is appropriated from the General Revenue
16 Fund to the Board of Trustees of the University of Illinois
17 for costs associated with the Hispanic Center for Excellence
18 at the Chicago campus.

20 Section 35. The sum of \$200,000, or so much thereof as
21 may be necessary, is appropriated from the Emergency Public
22 Health Fund to the University of Illinois for costs and

1 expenses related to or in support of emergency mosquito
2 abatement.

4 Section 40. The sum of \$200,000, or so much thereof as
5 may be necessary, is appropriated from the Used Tire
6 Management Fund to the University of Illinois for costs and
7 expenses related to or in support of mosquito research and
8 abatement.

9

10 Section 45. The sum of \$472,100, or so much thereof as
11 may be necessary, is appropriated from the Hazardous Waste
12 Research Fund to the University of Illinois for its ordinary
13 and contingent expenses.

14

15 Section 50. The sum of \$350,000, or so much thereof as may
16 be necessary, is appropriated from the General Revenue Fund
17 to the Board of Trustees of the University of Illinois for a
18 grant to the College of Dentistry.

19 Section 55. The sum of \$350,000, or so much thereof as
20 may be necessary, is appropriated from the General Revenue
21 Fund to the Board of Trustees of the University of Illinois
22 for Dixon Springs Agricultural Center.

24 Section 60. The sum of \$1,250,000, or so much thereof as

1 may be necessary, is appropriated from the General Revenue
2 Fund to the Board of Trustees of the University of Illinois
3 for costs associated with the Public Policy Institute at the
4 Chicago campus.

5

6 Section 65. The sum of \$1,000,000, or so much thereof as
7 may be necessary, is appropriated from the General
8 Professions Dedicated Fund to the Board of Trustees of the
9 University of Illinois for costs associated with the
10 development, support, or administration of pharmacy practice
11 education or training programs for the College of Medicine at
12 Rockford.

13 Section 70. The sum of \$1,000,000, or so much thereof as
14 may be necessary, is appropriated from the General Revenue
15 Fund to the Board of Trustees of the University of Illinois
16 for the ordinary and contingent expenses of technology
17 transfer.

18 Section 75. The sum of \$4,386,034, or so much thereof as
19 may be necessary and remains unexpended at the close of
20 business on June 30, 2009, from a reappropriation heretofore
21 made for that purpose in Article 40, Section 5 of Public Act
22 95-734, as amended, is reappropriated from the Capital
23 Development Fund to the Board of Trustees of the University

1 of Illinois for all costs associated with the space needs of
2 the Department of Natural Resources, Illinois Natural History
3 Survey Division and State Water Survey Division, on the
4 campus of the University of Illinois in Champaign, including
5 construction, capital facilities, planning, relocation,
6 renovation and rehabilitation, mechanical systems, materials,
7 services, and all other costs required to complete the work.

8 Section 80. The sum of \$134,917, or so much thereof as
9 may be necessary and remains unexpended on June 30, 2009,
10 from a reappropriation heretofore made for such purpose in
11 Article 40, Section 10 of Public Act 95-734, is
12 reappropriated from the Capital Development Fund to the
13 University of Illinois for digitalization infrastructure for
14 WILL-TV (Urbana-Champaign).

15 Section 99. Effective date. This Act takes effect July 1,
16 2009.
