1 AN ACT concerning elections.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The Election Code is amended by changing Section
16-6 as follows:

6 (10 ILCS 5/16-6) (from Ch. 46, par. 16-6)

7 Sec. 16-6. Whenever one or more proposals for amendment of 8 the constitution or the calling of a constitutional convention 9 or any combination thereof is or are to be voted upon by the people, the proposition or propositions for the adoption or 10 rejection of such amendment or amendments or convention shall 11 be submitted upon a ballot separate from the "Official Ballot" 12 containing the names of candidates for State and other offices 13 14 to be voted at such election. Such separate ballot shall be 15 printed upon paper of a distinctly blue color and shall, as 16 near as may be practicable, be of uniform size and blue color, 17 but any variation in the size of such ballots or in the tincture of blue employed shall not affect or impair the 18 validity thereof. Preceding each proposal to 19 amend the 20 constitution shall be printed the brief explanation of the 21 amendment, prepared by the General Assembly, or in the case of 22 a proposed amendment initiated by petition pursuant to Section 3 of Article XIV of the Constitution of the State of Illinois 23

Immediately above the words ballots 25 "CONSTITUTION BALLOT" in the case of a proposition for the 26 calling of a constitutional convention the following legend

9 Immediately above the words "CONSTITUTION BALLOT", in the 10 case of a proposition to amend the Constitution or for the 11 calling of a constitutional convention, the following legend 12 shall be printed in bold face type:

"NOTICE

WHETHER YOU VOTE THIS BALLOT OR NOT YOU MUST RETURN IT TO 14 THE ELECTION JUDGE WHEN YOU LEAVE THE VOTING BOOTH." 15

If a proposition for the calling of a constitutional 16 17 convention is submitted at the same election as one or more propositions to amend the constitution, the proposition for the 18 calling of a constitutional convention shall be printed at the 19 20 top of the ballot. In such case, the back or outside of the ballot shall be printed the same as if it were a proposal 21 22 solely to amend the constitution.
