A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named amounts, or so much  
6 thereof as may be necessary, respectively, for the objects  
7 and purposes hereinafter named, are appropriated to the Board  
8 of the Trustees of Western Illinois University to meet  
9 ordinary and contingent expenses for the fiscal year ending  
10 June 30, 2010:

11 Payable from the General Revenue Fund:

12	For Personal Services, including payment	
13	to the university for personal services	
14	costs incurred during the fiscal year	
15	and salaries accrued but unpaid to academic	
16	personnel for personal services rendered	
17	during the academic year 2009-2010 .....	48,775,000
18	For State Contributions to Social	
19	Security, for Medicare .....	436,200
20	For Group Insurance .....	1,706,400
21	For Contractual Services .....	3,272,900

1	For Commodities .....	782,500
2	For Equipment .....	978,100
3	For Telecommunications Services .....	<u>440,000</u>
4	Total	\$56,391,100

5 Section 10. The amount of \$10,000, or so much thereof as  
6 may be necessary, is appropriated from the State College and  
7 University Trust Fund to the Board of Trustees of Western  
8 Illinois University for scholarship grant awards from the  
9 sale of collegiate license plates.

10 Section 15. In addition to any other amounts  
11 appropriated for such purposes, the following named amounts,  
12 or so much thereof as may be necessary, are appropriated from  
13 the General Revenue Fund to the Board of Trustees of Western  
14 Illinois University for the fiscal year beginning July 1,  
15 2009, pursuant to Title XIV of the American Recovery and  
16 Reinvestment Act of 2009:

17	For Personal Services .....	\$3,528,500

18 Section 20. In addition to any other amounts  
19 appropriated for such purposes, the following named amounts,  
20 or so much thereof as may be necessary, are appropriated from  
21 the General Revenue Fund to the Board of Trustees of Western  
22 Illinois University for the fiscal year beginning July 1,

1 2009, pursuant to Title XIV (Other Government Services) of  
2 the American Recovery and Reinvestment Act of 2009:

3 For Personal Services .....\$973,800

4 Section 99. Effective date. This Act takes effect July 1,  
5 2009.
