1 AMENDMENT TO SENATE BILL 3584

2 AMENDMENT NO. \_\_\_\_\_. Amend Senate Bill 3584 by replacing  
3 everything after the enacting clause with the following:

4 "Section 5. The Illinois Vehicle Code is amended by adding  
5 Section 18d-153 and by changing Section 18d-160 as follows:

6 (625 ILCS 5/18d-153 new)

7 Sec. 18d-153. Misrepresentation of affiliation. It shall  
8 be unlawful for any tower to misrepresent an affiliation with  
9 the State, a unit of local government, an insurance company, a  
10 private club, or any other entity for the purpose of securing a  
11 business transaction with a vehicle owner or operator.

13 Sec. 18d-160. Unlawful practice. Any commercial vehicle  
14 safety relocater engaged in the relocation or storage of  
15 damaged or disabled vehicles who fails to comply with Sections

1 18d-115, 18d-120, 18d-125, 18d-130, 18d-135, ~~or~~ 18d-150, or  
2 18d-153 of this Code commits an unlawful practice within the  
3 meaning of the Consumer Fraud and Deceptive Business Practices  
4 Act.

6 Section 10. The Consumer Fraud and Deceptive Business  
7 Practices Act is amended by changing Section 2Z as follows:

9 Sec. 2Z. Violations of other Acts. Any person who knowingly  
10 violates the Automotive Repair Act, the Automotive Collision  
11 Repair Act, the Home Repair and Remodeling Act, the Dance  
12 Studio Act, the Physical Fitness Services Act, the Hearing  
13 Instrument Consumer Protection Act, the Illinois Union Label  
14 Act, the Job Referral and Job Listing Services Consumer  
15 Protection Act, the Travel Promotion Consumer Protection Act,  
16 the Credit Services Organizations Act, the Automatic Telephone  
17 Dialers Act, the Pay-Per-Call Services Consumer Protection  
18 Act, the Telephone Solicitations Act, the Illinois Funeral or  
19 Burial Funds Act, the Cemetery Oversight Act, the Cemetery Care  
20 Act, the Safe and Hygienic Bed Act, the Pre-Need Cemetery Sales  
21 Act, the High Risk Home Loan Act, the Payday Loan Reform Act,  
22 the Mortgage Rescue Fraud Act, subsection (a) or (b) of Section  
23 3-10 of the Cigarette Tax Act, subsection (a) or (b) of Section  
24 3-10 of the Cigarette Use Tax Act, the Electronic Mail Act, the

1 Internet Caller Identification Act, paragraph (6) of  
2 subsection (k) of Section 6-305 of the Illinois Vehicle Code,  
3 Section 18d-115, 18d-120, 18d-125, 18d-135, ~~or~~ 18d-150, or  
4 18d-153 of the Illinois Vehicle Code, Article 3 of the  
5 Residential Real Property Disclosure Act, the Automatic  
6 Contract Renewal Act, or the Personal Information Protection  
7 Act commits an unlawful practice within the meaning of this  
8 Act.
